M/s Raftaar Terminals Private Limited.:-
Cancellation of LoA & Surrender of allotted Plot in Dahej SEZ.

M/s Raftaar Terminals Private Limited, Mangalore was issued Letter of Approval dated 10.10.2018 for Storage/ warehousing services.

The unit requested vide their letter dated 22.07.2019 to surrender letter of approval and exit as Dahej SEZ Unit. The case was put up in 92nd UAC Meeting held on 27.08.2019 but the applicant vide email dated 27.08.2019 has sought leave of absence hence the case was deferred for the next meeting. The case was again put up in 93rd UAC, Dahej SEZ held on 15.10.2019.

M/s Dahej SEZ Limited, Dahej SEZ submitted vide their letter dated 19.02.2020 and Specified Officer, Dahej SEZ vide their letter dated 27-05-2020 submitted No dues certificate in respect of M/s Raftaar Terminals Private Limited. M/s. Raftaar Terminals Private Limited vide their letter dated 16.11.2019 submitted Undertaking on stamp paper for Duty and Taxes if any.

In view of the above, request of M/s. Raftaar Terminals Private Limited for exit from Dahej SEZ unit is once again placed before the UAC for consideration

M/s Meghmani Industries Limited.

Approval for acquiring the additional land adjacent to their existing LoA.

M/s. Meghmani Industries Limited were approved vide LoA dated 03.03.2008 for setting up of new unit in Dahej SEZ. They were allotted plot no. Z/6 and started commercial production from 26.05.2011.

Now the unit requested vide their letter no.MM/DCSEZ/19-20/004 dated 21.02.2020 for approval for 4355 Sq.mt area in existing LoA at Dahej SEZ. They have also got letter dated 17.02.2020 from Dahej SEZ Limited for allotment of 4355 Sq.Mtr approximate land in the processing area of Dahej SEZ. The Approval Committee may kindly consider the approval for the said request.

M/s Sigachi Industries Limited.

Change in name of the Company.

M/s. Sigachi Industries Private Limited was issued Letter of Approval dated 11.09.2008 to manufacture and export of " Micro Crystalline Cellulose". The unit has started commercial production with effect from 30.08.2012.

M/s. Sigachi Industries Private Limited has requested vide letter dated 06.02.2020 & 19.03.2020 for Change of name from M/s. Sigachi Industries Private Limited to M/s. Sigachi Industries Limited. The applicant has submitted copy of Registrar of Companies, Hyderabad with effect from 09.12.2019.
