## **CASE NO. B-01**

## 1. M/S. TORRENT ENERGY LTD.

M/S. Torrent Energy Ltd., a Unit in Dahej SEZ was issued an LOA for manufacturing and distribution of electrical power. As Power generation will take time of 3 to 4 years, firm wants to purchase the power from DTA and distribute the same in SEZ.

As this above activity amounts to trading activity, it was decided in the last meeting of the approval committee, to check that whether similar arrangements has been done in any other SEZ, if it is so then the same procedure may be adopted for the firm's proposal.

After proper inquiry to other SEZs it is found that there is no such type of arrangements in any other SEZ. The matter has been taken up to the Zonal Development Commissioner, Kandla.
