**AGENDA NOTE FOR THE APPROVAL COMMITTEE
FOR DAHEJ - SPECIAL ECONOMIC ZONE**

**Subject: - Action Taken Report of the Development Commissioner,
Dahej - SEZ, and grant of post-facto approval thereof.**

M/s. Dahej SEZ Ltd., (a joint venture of GIDC & ONGC) were approved by the Government vide Notification No. S.O. 2131 (E), dated 20-12-2006, to set-up a Multi-product SEZ at Villages Dahej, Ambheta, Luvara, Suva, Lakhigam and Jageshwar in Taluka Vagra, District Bharuch, over an area of 1718-93-87 hectares.

In absence of constituted and notified Approval Committee for Dahej SEZ Ltd., the Development Commissioner (DC for short), Kandla - SEZ, and thereafter the DC, Dahej SEZ had exercised the powers under Section-14 (2) of the SEZ Act, 2005, and considered various proposals and granted approvals thereof.

However, the Government of India in the Ministry of Commerce & Industry had constituted and notified an Approval Committee vide Notification No. S.O. 993 (E) dated **25-04-2008** (copy circulated to all Approval Committee members). The said notification was received by the office of the DC, Dahej - SEZ, during the month of August, 2008, thus during the intervening period from 25-04-2008 till 31-07-2008, the DC, Dahej - SEZ had considered various proposals and approvals granted thereof. A list of approvals granted is enclosed (Annexure - I) to this note.

In view of the above the Approval Committee may kindly grant post-facto approval on the action taken by the DC, Dahej - SEZ.
