#### <u>CASE NO. 25.2.1 [A-1]</u>

#### 1. MS.CHEMORGE (JAIN)

The case of M/s.Chemorge (Jain) was deferred from last UAC(24<sup>th</sup>) meeting as equity share of the original owner is less than 51% in the new company. As per Ministry letter No.F.2/9/2003-EPZ dated 19.10.2010 to transfer the ownership from existing company to another company, at least 51% equity is held by the original owner of the unit.

M/s.Chemorge (Jain) has revised the equity structure of the new company and now the original owner i.e. Shri S.C. Damani has 51% holding in the new company viz. M//s.Glomet Technologies Pvt. Ltd. Request of the unit to change the ownership is once again put up to the Approval Committee for consideration.

## CASE NO. 25.2.2

#### 2. M/S. OIL AND NATURAL GAS CORPORATION (ONGC)

The case of M/s.Oil and Natural Gas Corporation (ONGC) was deferred from last UAC (24<sup>th</sup>) meeting. One meeting was held with DC and ONGC officials. DC directed that another meeting with Central Excise & Customs officers and DGFT may be called after getting clarification from the DGFT. ONGC yet to confirm the date.

## 1. M/S.DIC FINE CHEMICALS PVT. LTD.

(i) M/s.DIC Fine Chemicals Pvt. Ltd. has submitted an application for Backward Integration to Beta Blue Project. This is the 2<sup>nd</sup> phase for manufacture of beta blue pigment as backward integration project.

They projected NET foreign exchange inflow for the five years period is `551.33 Crores. Total investment is `270.2 Crores. They further submitted that the project will be funded by way of inward remittance in a combination of Share Capital and or Preference Share and or any other financial support structure by DIC Asia Pacific Pte Ltd., Singapore (DICAP) as promoter of DIC Fine Chemicals Private Limited (DFC). Due to this broadbanding employment generation is 114 persons.

M/s.DIC Fine Chemicals Pvt. Ltd. has already started their exports in the current year of 2010.

#### 2. M/S.THE SARASWATI INDUSTRIAL SYNDICATE LTD.

M/s.Saraswati Industrial Syndicate Ltd. vide their Letter dated 22.10.2010 has requested to change the name of the unit from "M/s.Saraswati Industrial Syndicate Ltd." to "ISGEC (Prop. The Saraswati Industrial Syndicate Ltd.)"

M/s.Saraswati Industrial Syndicate Ltd. has three units viz. (i) ISGEC (ii) Isgec John Thompson and (iii) Uttar Pradesh Steels.
