Gujarat State Petronet Ltd. vide letter No.GSPL/F&A/183 dated 08.04.2011 submitted a half yearly certificate required under Rule 12(7) of the SEZ Rules, 2006 regarding utilization of goods. As per the said Rule, the certificate for utilization of goods should be from an independent Chartered Engineer. M/s. Gujarat State Petronet Ltd. requested that as the company would not avail benefits of exemption of any indirect taxes as available under SEZ Act, 2005, they should be exempted from submitting half yearly certificate regarding utilization of goods from an independent Chartered Engineer.
- (ii) M/s. Gujarat State Petronet Ltd. vide letter No.GSPL/F&A/184 dated 08.04.2011 submitted a Quarterly (January-2011 to March-2011) and Half Yearly (October-2010 to March-2011) Reports in Form-E under Rule 12(6) and 22(4) of the SEZ Rules, 2006. M/s.GSPL submitted that all goods used in the project were duty paid. No exemption available under SEZ Act, 2005 was availed by GSPL and contractors.
