Brief Note

The proposal of M/S. J S Chemical Industries is for setting up a new unit in the Dahej-SEZ. They have import Rs. NIL of capital goods for the proposed project. FOB value of exports for the 5 years period is projected as Rs. Rs.10938.00 Lakhs with NFE of Rs. 7110.00 Lakhs (185.74%) . The Developer (Dahej SEZ) has agreed in principle approval for allotment of plot of about 10,000-12,000 Sq. Mtrs in the processing zone of Dahej SEZ for the proposed project in Dahej SEZ for setting up of unit.

The proposal is eligible for approval under A/A route. We may therefore if approved, place the same before the **Approval Committee** for consideration, after personal interview of the Promoters/Directors. The proposal is recommended for approval in terms of the Rule-18 of the SEZ Rules, 2006.

M/S. TORRENT ENERGY LTD.

M/s.Torrent Energy Ltd. vide letter dated 20.04.2012 submitted a list of goods and services for approval. M/s.Torrent Energy Ltd. vide letter dated 22.03.2012 opted to work as a Co-Developer only in Dahej SEZ and sought for permission to exit as a Unit and cancel the LoA granted as a Unit. Upon a request of M/s.Torrent Energy Ltd., a fresh Eligibility Certificate was issued on 10.04.2012 to avail various tax exemptions as a Co-Developer in Dahej SEZ.

As per Rule 12 of the SEZ Rules, 2006, a Developer has to obtain approval from Approval Committee for the goods and services, including machinery, equipments and construction materials required for authorized operations.

A list of goods received from M/s.Torrent Energy Ltd. is enclosed herewith as Annexure-II.

CASE NO. 39.5.3

M/S. FERMENTA BIOTECH LTD.

M/s.Fermenta Biotech Ltd.(FBL) vide letter dated 23.04.2012 requested for permission to carry out trial batches for development of Import Substitute input for approved product in LoA.

FBL was issued the LoA for manufacture of Vitamin D3 and other products. They have submitted that the key starting material for manufacturing of Vitamin D3 is Cholesterol which was currently imported from overseas suppliers. Earlier FBL vide letter dated 07.01.2012 has requested for one time permission to carry out Trial batches for development of Import Substitute input for approved product in LoA which was approved by the Approval Committee

They have initiated the backward integration of development of Cholesterol successfully and planning to scale-up this process at their plant in Dahej by taking four trial batches. The input required for this plan trials would be procured without availing any fiscal benefits available under SEZ Rules and the Cholesterol obtained from trial batches would be consumed in Vitamin D3 manufacturing at their Dahej plant only.

Now FBL requested for permission to carry out the trials on the processing of additional 4 tons of Wool Grease to ascertain the process and its viability.
