Item No. 64.3.01

M/s. Gujarat Alkalies and Chemicals Limited- Request for permission for transportation of HDPE pipes and accessories to work at offshore segment in the Sea through SEZ Road from entry gate Port area to Light House.

M/s. Gujarat Alkalies and Chemicals Limited vide their letter no. GACL/DHJ/Civil/15-16 dated 08/09/2015 has requested for permission for transportation of HDPE pipelines, RCC ballast block, MS-HDG vertebra armours, lateral anchoring assemblies, welding machine, workmen, GACL/Contractors, tractor with trolleys, car/jeep, construction equipments etc. for the period of 10 months i.e. 02.09.2015 to 30.06.2016 to work at offshore segment in the Sea through non-processing area SEZ Road from entry gate Port area to Light House. They informed that this is the only area available for initiating the work in I/T & Offshore segment area. They have also obtained NOC from Dahej SEZ Ltd. for using SEZ road from entry gate port area to light house.

M/s. Roxul Rockwool Dahej -SEZ, Bharuch - Request for additional authorized operation.

M/s. Roxul-Rockwool Insulation India Pvt. Ltd., were approved vide LOA dated 01.12.2008, for setting-up of new unit in Dahej-SEZ for manufacture and export of 1) Pipe Section; 2) Slabs; 3) Wired Mats.
