**Brief Note**

The proposal of M/S Britannia Industries Limited., is for setting up a new unit in the Dahej-SEZ. They have import of Rs.1500.00 Lakhs capital goods for the proposed project. FOB value of exports for the 5 years period is projected as Rs. 48841.00 Lakhs with NFE of Rs.35881.00 Lakhs (73.46 %). The Developer (Dahej SEZ) has agreed in principle approval for allotment of plot of about 80,000 Sq. Mtrs. in the processing zone of Dahej SEZ for the proposed project in Dahej SEZ for setting up of unit.

The proposal is eligible for approval under A/A route. We may therefore if approved, place the same before the **Approval Committee** for consideration, after personal interview of the Promoters/Directors. The proposal is recommended for approval in terms of the Rule-18 of the SEZ Rules, 2006.
