Brief Note

The project proposal of M/s. Silvershine Corporation, of Mumbai, a proprietorship firm of Shri Shishir S. Jalundhwala, is for setting up a new unit in the Dahej-SEZ for manufacture and export of “1) Aluminum Granules; 2) Paper Disposable Products”. They propose to procure capital goods worth Rs. 250.00 lakhs. The projected export is Rs. 20000.00 lakh, with outgo of Rs. 3500.00 lakh, resulting in Net Foreign Exchange earnings of Rs. 16500.00 lakh. The Developer (Dahej SEZ) has agreed in principle approval for allotment of plot of about 5,000 Sq. Mtrs. in the processing zone of Dahej SEZ for the proposed project in Dahej SEZ for setting up of unit.

One of the proposed items of manufacture i.e. ‘Aluminum Granules’ is to be manufactured by recycling of aluminum scrap. Proposal for recycling of any used material in the SEZ is not to be considered in terms of Rule-18 (4) (d) of the SEZ Rules, 2006. The Approval Committee may kindly like to consider the second item i.e. ‘Paper Disposable Products’.

The proposal is eligible for approval under A/A route. The above proposal is placed before the **Approval Committee** for consideration, after personal interview of the Proprietor. The proposal is recommended for approval in terms of the Rule-18 of the SEZ Rules, 2006.

54.2 Deferred cases for Dahej – SEZ:-

54.2.1 M/s. Breeze Intermediates Pvt. Ltd., Dahej-SEZ – request for broad-banding of LOA.

M/s. Breeze Intermediates Pvt. Ltd., Dahej-SEZ vide their application dated 02-02-2014 have requested for approval to broad-banding of their LOA to include additional/new 72 (seventy-two) items/products for manufacturing, and export, as per the list enclosed. These proposed new items are freely importable and exportable under the ITC (HS) Classification. This case was put-up before the Approval Committee in its 53rd meeting held on 02-05-2014, and was deferred as none of the authorized representative of the applicant company appeared before the Committee to explain their proposed request for broad-banding of LOA. Thus, the request is re-submitted before the Approval Committee for necessary consideration, in terms of Rule-19 (2) of the SEZ Rules, 2006.

54.2.2 M/s. Hanzi Healthcure Pvt. Ltd., Dahej-SEZ – request for broad-banding of LOA.

M/s. Hanzi Healthcure Pvt. Ltd., Dahej-SEZ, were approved by this Approval Committee in its 50^s meeting held on 23-09-2013, and LOA dated 07-10-2013 was issued to them for manufacture and export of "1) Iodine products; and, 2) Pine Oil".

The approval holder (Hanzi) has sought approval for addition of new items and 'trading' of "1) Inorganic Chemicals; 2) Organic Chemicals; 3) Flavors & Fragrances; 4) Food Supplements/Food Products; and 5) Botanical & Naturaceuticals".

The case was put-up before the 53rd meeting of Approval Committee held on 02-05-2014, wherein the Committee had asked the applicant to furnish the details of investment made in SEZ alongwith specific mile-stones in order to commence commercial production in the SEZ of the approved items. M/s. Hanzi Healthcure Pvt. Ltd., vide their letter dated 07-06-2014 have stated that after getting mandatory/statutory approvals they shall start construction of building by January, 2015, installation of plant & machineries by December, 2015, and commence production by March, 2016. And for the SEZ project they have made an investment of Rs. 37.34 lakh.

In view of the clarifications given by the applicant, the case is re-submitted before the Approval Committee for necessary consideration, in terms of Rule-19 (2) of the SEZ Rules, 2006

54.3 Other cases for Dahej – SEZ:-

Item No. 54.3.1 M/s. Accent Microcell Pvt. Ltd., Dahej-SEZ – request for broad-banding.

M/s. Accent Microcell Pvt. Ltd., Dahej-SEZ is issued LOA dated 26-06-2012, as amended/extended from time-to-time, for manufacture and export of 'Micro Crystalline Cellulose Powder'. They commenced their trail/commercial production in SEZ, during December, 2013.

Now the unit, vide their application dated 15-05-2014 have requested for broad-banding of their LOA to include 02 (two) new products. These items are 1) Magnesium Stearate (MS –

28332990); and 2) Cross Carmellose Sodium (CCS – 391231000). Since, they have commenced trail/commercial production in the SEZ, the said proposal is recommended for approval to broad-band the LOA to include new products, in terms of Rule-19 (2) of the SEZ Rules, 2006, subject to normal terms and conditions.

Item No. 54.3.2 M/s. Tega Industries (SEZ) Ltd., Dahej-SEZ – request for broad-banding.

M/s. Tega Industries (SEZ) Pvt. Ltd., Dahej-SEZ is issued LOA dated 14-02-2011, as amended/extended from time-to-time, for manufacture and export of '1) Mill Liners; 2) Pump parts; & 3) Chute & Hooper Liners [under chapter-40 of the ITC(HS)]'. They had commenced commercial production in SEZ, with effect from 15-09-2013, and have export goods worth Rs. 49.91 crore as on 31-05-2014 with positive NFE.

Now the unit, vide their application dated 19-05-2014 have requested for amplification/broad-banding of their LOA to include 05 (five) new products. These items are 1) Vulcanized Rubber Sheet (40081190); 2) Rubber Screen Panel & Accessories (40169000); 3) Ceramic Rubber Liner (40169000); 4) Rubber line trammel structure with screen panel (40169000); and 5) Rubber Compound (40051000). Since, they have commenced commercial production in the SEZ, with substantial investment, employment, and exports, the said proposal is recommended for approval to broad-band the LOA to include new products, in terms of Rule-19 (2) of the SEZ Rules, 2006, subject to normal terms and conditions.

Item No. 52.2.5 M/s. Sapthagiri Hospitality Pvt. Ltd., Dahej – SEZ:-

M/s. Sapthagiri Hospitality Pvt. Ltd., Co-developer in Dahej-SE vide letter dated 24-06-2014 (copy enclosed) have sought approval for procurement of duty-free materials for the following approved & default Authorized Operation, to be undertaken in the notified SEZ, at Dahej:-

The activities proposed are covered in the default list of activities notified by the MOC&I, vide Instruction No. 50, dated 15-03-2010, and approved list vide DOC's letter No. F.2/9/2003-EPZ, dated 22-12-2009.

The above request of the Co-Developer (Sapthagiri) merits consideration in terms of Rule-10 & 12 of the SEZ Rules, 2006.

Put up for consideration and approval by the Approval Committee.

Item No. 52.2.5 M/s. Torrent Energy Ltd., Dahej – SEZ:-

M/s. Torrent Energy Ltd., co-developer vide letters dated 28-04-2014, and 23-05-2014 (copies enclosed) have sought approval for procurement of duty-free materials for the following default Authorized Operation, to be undertaken in the notified SEZ, at Dahej:-

- a) Electrical, gas and petroleum gas distribution network including necessary sub-stations of appropriate capacity, pipeline network;
- b) Telecom and other communications facilities including internet connectivity;
- c) Construction of all types of Buildings in Processing area;

- d) Air conditioning of Processing area; and
- e) Solid & liquid waste collection, treatment and disposal plants including pipelines and other necessary infrastructure for sewage and garbage disposal, sewage treatment plants.

The activities proposed are covered in the default list of activities notified by the MOC&I, vide Instruction No. 50, dated 15-03-2010.

The above request of the Co-Developer (TEL) merits consideration in terms of Rule-10 & 12 of the SEZ Rules, 2006.

Put up for consideration and approval by the Approval Committee.

Item No.54.3.5 **Approval of list of services in respect of Developer and units in Dahej - SEZ.**

In terms Section-26 of the SEZ Act, 2005, read with Rule-31 of the SEZ Rules, 2006; quote *“Exemption from service tax:- The exemption from payment of service tax on taxable services under section-65 of the finance Act, 1994 (32 of 1994) rendered to a Developer or a Unit (including a Unit under construction) by any service provider shall be available for the authorized operations in a Special Economic Zone”* unquote.

Under the above SEZ provisions a Developer or a Unit was exempted from payment of Service Tax on taxable services. However, the Government of India, in the Ministry of Finance, had amended the aforesaid provision vide CBEC Notification No. 9/2009-Service Tax, dated 03-03-2009, as amended from time-to-time, wherein the developer or units of SEZ shall have to get the list of services approved from the Approval Committee, as specified services, for the required exemption, etc.

The Department of Commerce, in view of bringing uniformity, in the list of taxable services applicable for all SEZs in India, devised a default list of 60 (sixty) services. These 60 services were approved as default services in the 61st Approval Committee for Kandla – SEZ held on 18-11-2013. This approved list of Services was circulated to all the SEZs in Gujarat, vide F. No. KASEZ/IA/G-02/2009-10/ dated 19-11-2013. The same is annexed for reference. The Developer, Co-Developers, and the units of Dahej - SEZ have requested for approval of the services as listed below, which are in addition to the default list of 60 services:-
