Brief Note

The proposal of M/s. Meghna Colour Chem Pvt Ltd, is for setting up a new unit in Dahej-SEZ. They have import of capital goods of Rs. 1500.00 Lakhs for the proposed project. FOB value of exports for the 5 years period is projected as Rs. 44397.01 Lakhs with NFE of Rs. 44397.01 Lakhs. The Developer (Dahej SEZ) has agreed in principle approval for allotment of plot of about 12,000 Sq. Mtrs. in the processing zone of Dahej SEZ for the proposed project in Dahej SEZ for setting up of unit.

In view of the above, the proposal for setting up of the unit is placed before Unit Approval Committee for consideration, and personal interview of the Director. The same is recommended for approval in terms of Rule 18 of the SEZ Rules, 2006.

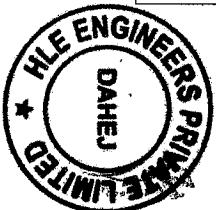
We are pleased to enclose herewith the first purchase order copy bearing no. 15421 dated 8th September 2023 and the FOB value is approximately Rs. 5.53 crores. The POD is Koper (Slovenia) for the first order.

We had committed the export obligations, but circumstances went beyond our control due to DSL's inefficiency and the sudden outbreak of pandemic CORONA and clamping of curfew across India. Till licenses are in place and manufacturing starts, we have no other option other than enter into trading business to avoid cancellation of the long term order from Europe & USA.

Despite all the odds, we constructed a warehouse fully at the plot and are fully operational. The purchase order copy enclosed perse is self-explanatory for the fact that we will export the goods and bring Foreign Exchange subject to grant of license by your office. Kindly consider our case as a special one owing to the challenges we faced and went through since the allotment of the plot to us on 12th April 2018. We request your office to kindly endorse in our LoA broad banding and extend the LoA from 14th October 2023 to a further 5 years since ours is a genuine case.

The eviction of locals in the plot with the help of police and the subsequent outbreak of pandemic delayed licensing process and construction activities. Once the licenses are procured for manufacturing and plant is set up we will export larger quantities to US and Europe.

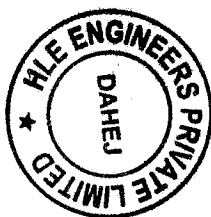

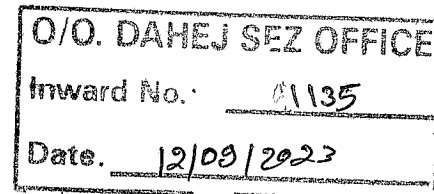

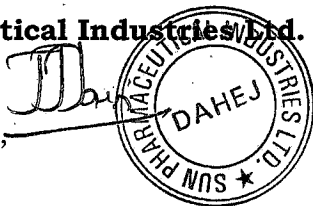
