M/s Arham Biochem Private Limited

Request for change of name/transfer of land in favor of M/s Kumar Organic Products Limited

M/s Arham Biochem Private Limited (Earlier known as M/s Bitumode International Private Limited) was issued LOA on 02.04.2012, as amended from time to time, for manufacturing and export of items mentioned under various HS Codes falling under Chapter 39, 56 & 68 and had started commercial production with effect from 29.03.2016.

The 107th UAC meeting held on 14.06.2022 had approved the request of the firm for change in composition of the Board of Directors and Shareholding pattern of the firm.

The 109th UAC meeting held on 27.12.2022 had approved the request of the firm for change in name of the firm from M/s Bitumode International Private Limited to M/s Arham Biochem Private Limited.

This office vide letter dated 19.11.2024 had requested the firm to submit the revised/amended Registered Lease Deed to this office. But till date, the firm had not submitted the same to this office.

M/s DSL vide letter dated 28.02.2025 had requested the firm to make payment of Rs. 96,61,829 as Transfer fee to DSL for change of name of the firm from M/s Bitumode International Private Limited to M/s Arham Biochem Private Limited.

Now, M/s Arham Biochem Private Limited (has a valid letter of approval i.e. up to 28.03.2026) vide letter dated 04.04.2025 had requested this office for change of name/transfer of land in favor of M/s Kumar Organic Products Limited. The firm had requested for exit of their unit (Plot No. Z/43 & Z/44) from Dahej SEZ by transferring of assets/ land under the relevant Rule of SEZ. The firm had submitted list of Directors of M/s Kumar Organic Products Limited, Details for amendment/transfer of LoA and Products List. The firm has stated that they will have projected investment of Rs. 3000 Lakhs, Nil import projection for capital goods, Rs. 217 Crore projection for import of raw materials etc., employment projection is 200 persons, FOB value for export is Rs. 775 Crore, Foreign Exchange outgo is Rs. 217 Crore and NFE is Rs. 558 Crores.

As per Rule 74A of the SEZ Rules, 2006.

"Transfer of Assets by SEZ Units upon their exit: The unit may opt out of Special Economic Zone by transferring its assets and liabilities to another person by way of transfer of ownership including sale of Special Economic Zone units subject to the following conditions:

- (i) the Unit has held a valid Letter of Approval as well as lease of land (or Standard Design Factory) for not less than a period of five years on the date of transfer;
- (ii) the unit has been operational for a minimum period of two years after the commencement of production as on the date of transfer;
- (iii) such sale or transfer transactions shall be subject to the approval of the Approval Committee;
- (iv) the transferee fulfils all eligibility criteria applicable to a unit; and
- (v) the applicable duties and liabilities, if any, as calculated under rule 74, as well as export obligations of the transferor Unit, if any, shall stand transferred to the transferee Unit which shall be under obligation to discharge the same on the same terms and conditions as the transferor Unit.

The firm has not submitted the No Dues Certificate of the Specified Officer, Dahej SEZ and the Developer, Sale Purchase Agreement, Assets and liabilities ownership declaration, responsibility of Operations, past actions, liabilities and obligations declaration, Indemnity Bond, document evidencing repayment of Stamp duty.

The case of the firm was placed before the 130th Approval Committee for consideration and suitable decision.

The Developers representative have informed the committee that the firm has to amend the Registered Lease Deed in the name of M/s Arham Biochem Private Limited, since the name of the firm has been changed.

The 130th Approval Committee after detailed discussion unanimously deferred the proposal and directed the firm to submit the following documents: -

1. Submit a copy of Registered Lease Deed to the DC Office within 30 days (As per Rule 74-A of the SEZ Rules, 2006)

2. Submit a Certificate regarding duties and export obligations as per the Customs Act, 1962 from the Specified Officer, DC office (As per Rule 74-A of SEZ Rules, 2006)

3. Shipping Bill-wise statement of export from 2022-23 to 2024-25 duly certified by the Chartered Accountant to verify that they have maintained positive NFE since the firm has opted for exit from the SEZ (As per Rule 74 of SEZ Rules, 2006).

Hence, the case is again placed before the Approval Committee for consideration and suitable decision.

M/s. Raks Pharma Pvt Ltd.,
Application for Addition of Research and Development

Services in the existing LoA.

M/s Raks Pharma Pvt Ltd was issued a Letter of Approval dated 26.06.2012 as

amended from time to time, for setting up of a unit in Dahej SEZ for manufacturing and export of items mentioned under various HS Codes falling under chapter 28 & 29. The unit had started commercial production with effect from 22.10.2015.

M/s. Raks Pharma Pvt Ltd vide letter dated 06.05.2025 & 04.07.2025 had requested for addition of Research and Development Services in the existing LoA.

This office vide letter dated 29.05.2025 had requested the firm to submit the Registered Lease Deed, EC, GPCB CCA, approval of Petroleum and Explosives Safety Organization (PESO) and approval of Food & Drug Administration.

The firm vide letter dated 04.07.2025 had submitted the Registered Lease Deed, EC, GPCB CCA, approval of Petroleum and Explosives Safety Organization (PESO) and approval of Food & Drug Administration.

The firm had informed that they are not able to fully use their available capacity for export of goods. Inclusion of R&D activities will help them to make optimum use of their installed capacity. They wish to provide R&D services to customers outside India, as well as customers in SEZ/EOU/DTA. They had stated that they will ensure that they will maintain positive Net Foreign Exchange Earning (NFE) after inclusion of R&D activity.

The firm had also submitted the projection for next five years period as mentioned below: -
