Brief Note

The proposal of M/s. Mahesh Raj Chemicals Pvt Ltd., is for setting up a new unit in the Dahej-SEZ. They proposed to import of Rs. 1500.00 Lakhs capital goods for the proposed project. FOB value of exports for the 5 years period is projected as Rs. 33709.00 Lakhs with NFE of Rs. 29099.00 Lakhs (86.32 %). The Developer (Dahej SEZ) has agreed in principle approval for allotment of plot of about 20,000 Sq. Mtrs. in the processing zone of Dahej SEZ for the proposed project in Dahej SEZ for setting up of unit.

The above proposal has been scrutinized and recommended for personal interview of Promoters/Directors and consideration of approval for setting up a new unit in the Dahej SEZ after in terms of Rule 18 of the SEZ Rules, 2006.

<u>Item No. 78.02.</u> <u>Deferred cases for unit in Dahej -SEZ:-</u>

Item No. 78.02.01 M/s Meghmani Organics Limited.,-

Request for inclusion of additional item in the

existing LOA for Trading Activity.

The request of M/s Meghmani Organics Limited was placed before the 77th UAC meeting of Dahej SEZ held on 19-12-2017. The Senior General Manager of applicant unit submitted letter correcting the ITC HS code of one of the requested trading items during the meeting. The committee decided that Office of Development Commissioner will check the ITC HS Code of the requested trading items and other details as per SEZ Act & Rules.

The unit vide their letter dated 28.08.2017 requested to include additional items in LoA for trading activity i.e. 1) Pigment Red 122 (with different Grade as per application there of) ITC (HS) 32041790, 2) Pigment Violet 23 (with different Grade as per application there of) ITC (HS) 32041740, 3) Pigment Red 19 (with different Grade as per application thereof) ITC (HS) 32041740, 4) Dispersion Blue (SDA 500/600/120) ITC (HS) 32041159.

The Office of DC, Dahej SEZ checked the requested additional items and found that there is no classification under DGFT ITC(HS), 2018 Schedule 2- Export Policy Chapter 32.

As the unit is working and exporting from the SEZ, the Approval Committee may consider new items sought in their request for trading, in terms of Rule-19(2) of the SEZ Rules, 2006 subject to the normal terms and conditions.

M/s. Ajanta Pharma Limited., Dahej SEZ - Broad-banding
& inclusion of additional items & enhance Annual
Capacity for export of manufacturing goods under
Chapter 30 of ITC (HS) in existing LoA.

The request of M/s Ajanta Pharma Limited was placed before the 76th UAC meeting of Dahej SEZ held on 11-10-2017. The committee after detailed discussion deferred the case for proper clarification with literature from the unit and directed the unit to send a well conversant person to explain their request in detail to the Unit Approval Committee. The request was again placed before 77th UAC meeting but the request was deferred on the request of the applicant unit.

M/s Ajanta Pharma Limited was issued LOA on 02.04.2012, as amended from time to time, for manufacture and export of "Tablet, Capsules & Poweder in 1gm ITC(HS) Code 30 and started commercial production from 01.04.2017.

Now, M/s. Ajanta Pharma Limited., Dahej-SEZ, vide their letter dated 22/08/2017 requested for broad-banding of LoA & inclusion of additional item i.e. Oral Jelly with proposed 108 Million annual capacity under chapter 30 of ITC(HS).

The unit also requested to enhance Annual Capacity for manufacturing goods under Chapter 30 of ITC (HS) in existing LoA as per detail given hereunder:-

The unit also informed that they will not invest extra amount for generation of employment for all these new products & they will accommodate the same in present infrastructure & manpower which was already exceed proposed investment declared. They will increase their export by adding these new products by 50 Crores.

As the unit is working and exporting from the SEZ, the Approval Committee may consider the new items/enhancement of production capacity of existing item sought in their request, in terms of Rule-19(2) of the SEZ Rules, 2006 subject to the normal terms and conditions.

<u>Item No. 78.03</u> <u>Other cases for Dahej - SEZ</u>

Item No. 78.03.01 M/s GAIL (India) Limited-

Review of permission regarding laying of 8" Dia pipeline by tap off from existing GAII's DUPL 30" Dia Natural Gas Pipeline to OPaL across GIDC/SEZ area in existing ROU of GAIL.

The 76th Unit Approval Committee of Dahej SEZ decided to approve the request of GAIL (India) Limited (GAIL) and ONGC Petro addition Limited (OPaL) for laying Natural Gas Pipeline in across GIDC/SEZ area in the existing ROU of GAIL. The committee also decided that the no SEZ benefits shall be allowed for laying the pipeline outside the boundary of OPaL. In addition both GAIL and ONGC will comply with SEZ Act and Rules and all other relevant Rules & Regulations.

Gujarat State Petroleum Corporation Limited (GSPL), Co-Developer of Dahej SEZ filed SCA No.21738/2017 against GAIL, OPaL, DSL and UAC in the Hon"ble High Court of Gujarat. The petitioner requested to quash and set-aside the permission accorded by the UAC to GAIL for laying the gas pipeline and

restrain GAIL and OPaL for carrying out the activity. The GSPL claimed the sole and exclusive right with respect to development, operation and maintenance of gas transmission pipeline infrastructure and distribution of Gas within the area of Dahej SEZ as per clause 6 of the Co-Developer agreement which is form part of approval approved to M/s GSPL as Co-Developer in Dahej SEZ vide Department of Commerce, Govt. of India,(SEZ Section), New Delhi's letter No.F.2/9/2003-EPZ dated 12/11/2009.

Honorable High Court of Gujarat passed the judgment dated 26/12/2017 dismissing the petition SCA No.21738 of 2017 filed by GSPL. Now the Appellant – GSPL has filed Letter of Patent Appeal No.2619 of 2017 in SCA No.21738/2017 with CA No.17149/2017 against the GAIL, OPaL, UAC and DSL.

DCs meeting held on 19.01.2018 under the Chairmanship Additional Secretary, Department of Commerce clarified on the Court case filed by Developer of Dahej SEZ against the decision of UAC in allowing a unit to develop infrastructure for supply of gas. It was unanimously felt that the decision to allow a unit to develop infrastructure outside the land of the unit was not correct.

In view of the above, the case is placed before the UAC for appropriate decision.

<u>Item No. 78.03.02</u>

M/s Fermenta Biotech Limited.,-Proposal for amendment of typographical error in approval of broad-banding of LoA.

M/s Fermenta Biotech Limited (FBL), Dahej SEZ unit requested for broad-banding/inclusion of additional item Ergocalciferol (Vitamin D2) (Pharmaceutical & Food Grade), HS Code 29362940 3 MTPA. The request was placed before the 77th UAC, Dahej SEZ and the same was approved. But unfortunately the description of the product "Ergocalciferol (Vitamin D2) (Pharmaceutical & Food Grade) in oil" was wrongly mentioned.

The proposal for amendment of typographical error in the above decision is placed before the UAC for approval.

Item No. 78.03.03 M/s Arora Sales Agency,-

Broad-banding/inclusion of additional trading activities in the existing LOA

M/s Arora Sales Agency (plot No. Z-69) was issued Letter of Approval dated 14th June, 2011 as amended from time to time, for setting up unit in Dahej SEZ to manufacture items Carbon steel, Mild Steel, Alloy Steel, Structural Steel, Tor Steel, Pipe & Pipe Fittings in Dahej SEZ for manufacture and export. The applicant unit started their commercial production from 01.05.2013 and exported products of Rs.245.52 lakhs.

M/s Arora Sales Agency requested vide their letter dated 15.12.2017 for additional trading activities of Bottled Alcoholic Breverage having HSN Code: 2208. The applicant unit will purchases material from Planet F & B Park, Plot no.3/2 A, Sector-3, SEZ, KASEZ,Mundra SEZ, Bommidala Enterprises P Ltd. Plot no. 17, Unit no.III, Cochin SEZ and their unit Maharana Breverage & Bottling Pvt. Ltd., Abu Road, Rajasthan. The applicant unit will provide services for liquor card in SEZ areas of Gujarat as per the norms of Government of Gujarat. The unit will have a capacity of trading of Alcoholic Breverages 24 lacs liters per annum.

The request of M/s Arora Sales Agency for above additional trading activities is placed before UAC for consideration.

Item No. 78.03.04 M/s Gujarat Dyestuff Industries,Broad-banding/inclusion of additional item of exports for manufacturing in the existing LOA

M/s Gujarat Dyestuff Industries was issued Letter of Approval dated 1st December, 2008 as amended from time to time, for setting up unit in Dahej SEZ to manufacture items in Dahej SEZ (1) Vinyl Sulphone Ester (2) Hydrochloric Acid (3) Sulphuric Acid (Dilute) for export. The applicant unit started their commercial production from 29-11-2013. The unit submitted Annual Performance Reports upto 2016-17 showing Nil exports. Now the unit has submitted revised APR for the year 2014-15 showing the export of Rs.28.68 lakhs.

The applicant unit requested for broad-banding of additional item Acetic Anhydride, ITC (HS) Code No.29152400 with annual capacity of 14400 MT in the existing LOA for manufacturing activity. The unit projected investment of Rs.40 Crore, export of Rs.37.62 crores for first five years and employment of 40 to 60 employees. As per DGFT export policy ITC(HS) Code, 2018, No Objection Certificate from Narcotics Commissioner of India, Gwalior is required. The unit submitted letter from Zonal Director, Narcotics Controller Bureau, Ahmedabad informing that there is no need to obtain prior permission of this Zonal Unit for setting up a plant for manufacturing acetic Anhydride having 1200 MT capacity per month. However, before starting manufacturing of acetic anhydride, obtaining URN by this Zonal Unit is mandatory. The unit also submitted minutes 37th SEIAA meeting at GPCB, Gandhinagar held on 31/01/2018 granting environment clearance.

In view of the above, the proposal of M/s Gujarat Dyestuff Industries for broad-banding/inclusion of additional item of exports for manufacturing in the existing LOA is placed before UAC for consideration.

<u>Item No. 78.03.05</u> <u>M/s Vijay Tanks & Vessels (P) Limited-Request for exit from Dahej SEZ unit</u>

M/s Vijay Tanks & Vessels Limited, Vadodara was issued Letter of Approval dated 09/11/2010 and amended from time to time for manufacture and export of item (01) Storage Tanks Process Equipment with 2000 MT per annum. The unit was permitted to start the Services and activities for the EPC Projects for and at OPaL, Dahej SEZ from 05/04/2011. The validity of their Letter of Approval is upto

04-04-2021. The 74th Unit Approval Committee of Dahej SEZ held on 23-05-2017 monitored the APRs upto 2015-16 and noted Positive Net Foreign Exchange Earnings. The unit submitted physical APRs for the financial year 2016-17 and for the period from April, 2017 to 31/12/2017 wherein the verification of Exportimport data of APRs is awaited from the Specified Officer, Dahej SEZ.

The unit requested vide their letter dated 28/12/2017 to debond the Letter of Approval issued as Dahej SEZ unit.

In view of the above, request of M/s Vijay Tanks & Vessels (P) Limited for exit from Dahej SEZ unit is placed before the UAC for consideration.

Item No. 78.03.06

M/s Yashashvi Rasayan Pvt. Ltd.,Request for correction of Export Product HS
Code

M/s Yashshvi Rasayan Private Limited was issued Letter of Approval dated 27/01/2015 to manufacture and export of items 1) Dicamba 2) 3,6 Dichloro Salicylic Acid 3) 2,5 Dichloro Phenol 4) 2,5 Dichloro Anline under Chapter 29 & 38 of ITC HS.. The commenced their commercial production from 09/09/2017.

The unit requested vide their application dated 27/01/2018 for correction of Export Product Code of manufacturing product 3,6 DI CHLORO 2 METHOXY BENZOIC ACID (DICAMBA ACID TECHNICAL 98%) from HS code No.38089350 to 29189900. The unit has mentioned classification description and coding details of the product.

In view of the above, the request of M/s Yashashvi Rasayan Pvt. Ltd. for correction of Export Product HS Code is placed before the UAC for consideration.
