**M/s Shiva Pharmachem Limited.**

**Broad banding of manufacturing items**

M/s Shiva Pharmachem Limited submitted letter No.SPL/Dahej-SEZ/LOA/Addition dated 05-07-2018 enclosing the list of additional manufacturing items (ANNEXURE ENCLOSED) under chapter 29 of ITC (HS) code and requested to add in the Letter of Approval without enhancing existing LOA capacity. The applicant unit informed that many orders of these additional manufacturing items are in pipeline and in final stage of negotiation. There is a continuous research process within the span on existing major raw materials. These products will certainly increase the foreign currency inflow and boost the NFE.

The applicant unit was issued Letter of Approval No.Dahej SEZ/II/4/SHIVAPHARMACHEM/2010-11 dated 04/10/2010 to manufacture 1. Acid Chlorides 2. Alkyl Chlorides 3. Specialty Chemicals & Advance Intermediates 4. Agro Technical Products 5. Active Pharma Ingredients 6. Thinoyl Chlorides under chapter 28 & 29 of ITC (HS). The applicant unit commenced the

commercial production from 16-12-2014 and earned cumulative Net Foreign Exchange of Rs.14691.78 lakhs upto 31/03/2017.

In view of the above, the request of M/s Shiva Pharmachem Limited for broad banding of additional manufacturing items as enclosed annexure is placed before the committee for consideration.

**M/s Dahej SEZ Ltd.: -**

**Application for permission of Sub-Contracting/ Job Work as per rules 41(3) & 42 of SEZ Rules, 2006.**

M/s. Dahej SEZ Ltd., Gandhinagar a Developer of Multi Product Special Economic Zone has submitted application for permission of Sub-contracting/Job Work as per Rules 41(3) & 42 of SEZ Rules, 2006. Dahej SEZ Ltd was approved list of Goods including the chassis for Fire Tender vide letter dated 02.12.2013 for construction of 57-MLD Water Supply Scheme at Dahej SEZ in terms of Rule 10 and 12(2) of SEZ Rules, 2006. Now the Developer requests for permission of Sub-Contracting / Job Work as per Rules 41(3) & 42 of SEZ Rules, 2006 in the process of procurement of Multipurpose Fire Tender in SEZ. The Multipurpose Fire Tender requires specialized assembly of different parts from M/s N K Fire & Safety who is already having the required technology and machinery for the same. Chassis will go outside SEZ and will come after Job-Work.

M/s. DSL has submitted the following documents. 1. Application for Sub-Contracting/ Job Work Permission 2. Consent letter for Sub-Contract/Job Work 3. Annexure-I (process name along with Input-Output ratio).

**M/s Swarnim Dahej Spring Desalination P Ltd.: -**

**Proposal for cancellation of Letter of Approval**

Ministry of Commerce & Industry, Government of India, New Delhi vide their letter No.F.2/9/2003-SEZ dated 25<sup>th</sup> April, 2014 approved the proposal of M/s Swarnim Dahej Spring Desalination P Ltd (SDSDPLAR) as Co-Developer for providing infrastructure facilities to develop, operate and maintain desalination plant of 336 MLD capacity for supply of desalinated water to developer, co-developer and SEZ unit, over an area of 60 hectares.

M/s Dahej SEZ Limited, Developer of Dahej SEZ informed vide their letter dated 30/12/2017 that no work has been carried out by M/s SDSDPLAR and no payment has been made towards land allotted to the co-developer and requested to take suitable action against the co-developer.

In view of above, the proposal for recommendation of cancellation of Letter of Approval issued to M/s SDSDPLAR as Co-Developer, Dahej SEZ is placed before the committee for consideration.



**Item No. 81.03.04****M/s Dev International: -****Proposal for cancellation of Letter of Approval**

M/s Dev International was issued Letter of Approval No.DAHEJ/SEZ/II/007/2014-15 dated 20/04/2015 for Warehousing & Logistic Service Activity i.e. Handling & Transportation equipment. M/s Dahej SEZ Limited allotted plot No.Z/50 of 6251.28 sq. mts. in Dahej SEZ vide their agreement dated 30/05/2015. Bond-cum-Legal undertaking dated 18/11/2015 for Rs.1, 09, 00,000/- was executed and Eligibility Certificate for exemption of taxes was issued. A letter dated 12/08/2016, 03/01/2017, 23/01/2017 was sent to unit informing that Letter of Approval was expired on 19.04.2016, and requested to submit details for extension of LoA. The unit was informed vide letter dated 27/03/2017 that DC, Dahej SEZ is not convinced by the reason of delay for making application of extension of LoA dated 20.04.2015.

M/s Dahej SEZ Limited vide their letter No.DSL/DC/Unit progress/2017/3635 dated 12/12/2017 listed the unit in non-functional units and informed that Dahej SEZ has been receiving many inquiries for setting of new units, but due to unavailability of vacant plots their request is not accepted.

In view of above, the proposal for cancellation of Letter of Approval issued to M/s Dev International, Dahej SEZ is placed before the committee for consideration.

**Item No. 81.03.05****M/s Hanzi Healthcare Private Limited: -****Proposal for cancellation of Letter of Approval**

M/s Hanzi Healthcare Private Limited was issued Letter of Approval No.DAHEJ/SEZ/II/007/2014-15 dated 07/10/2013 for manufacture of Iodine products like Methyl Iodide, Ethyl Iodide, Potassium Iodide, Potassium Iodate {under chapter -28 of ITC (HS), Pipe Oil {under chapter -38 of ITC(HS)}. M/s Dahej SEZ Limited allotted plot No.Z/62 of 5,031.46 sq. mts. in Dahej SEZ vide their agreement dated 11/12/2013. Bond-cum-Legal undertaking dated 30/03/2014 for Rs. 60 lacs was executed. LoA was extended upto 06-10-2015 on 17-10-2014 and upto 06-10-2016 on 14/03/2016.

The unit informed vide their letter dated 03/09/2016 that they had visited site for Bhumi Pujan on 3<sup>rd</sup> Sept. but not able to do as the plot is half filled with effluent water. The Developer, Dahej SEZ informed vide their letter dated 26/10/2016 that the representative of M/s Hanzi Healthcare Private Limited had visited the plot on site on 16/09/2016 along with Manager (Infra) , it was observed that no effluent leakage, but Seepage from DSL storm water drain was observed. DSL had repaired the same. DSL also informed that no development/soil filling was done in the plot resulting in accumulation of rain water. Culvert drawing submitted by unit was not readable. In view of this, DSL has not executed lease deed with unit as requested by unit for getting soft loan from Bank. The unit vide their letter dated 24/05/2017 informed that the land is totally clear from the defects and they wish to start development work of land. The unit requested vide their letter dated 12/12/2017 to extend LoA citing the reasons for delay as per their submission dt. 03/09/2016.

The Specified Officer, Dahej SEZ reported vide their letter dated 02/01/2018 that officer of their office visited the site at Z/62 of SEZ, Dahej. The site being at the low lying area, the plot is waterlogged, fully covered by water-borne plants/creepers, and apparently there is no sign of discharge of effluent at the site. It has been observed that there is no construction/any type of activity going on at the site. The allotted land area is in "as it is" condition.

M/s Dahej SEZ Limited vide their letter No.DSL/DC/Unit progress/2017/3635 dated 12/12/2017 listed the unit in non-functional units and informed that Dahej SEZ has been receiving many inquiries for setting of new units, but due to unavailability of vacant plots their request is not accepted.

In view of above, the proposal for cancellation of Letter of Approval issued to M/s Hanz Healthcure Private Limited, Dahej SEZ is placed before the committee for consideration.

**Item No. 81.03.06    Monitoring of Performance of Dahej SEZ units**

Monitoring of Performance of SEZ unit in Dahej - SEZ in respect of performance upto the monitoring Year 2016-17.

Purpose and Statute: - Section-L{ of the SEZ Act,2005, read with Rule-54 of the SEZ Rules' 2006. "Rule-S4: Monitoring of Performance:- (1) Performance of the Unit shall be monitored by the Approval Committee as per the guidelines given in Annexure appended to these rules (2) In case the Approval Committee come to the conclusion that a Unit has not achieved positive Net Foreign Exchange Earning or failed to abide by any of the terms and conditions of "the Letter of Approval of Bond-cum-Legal Undertaking without prejudice to the action that may be taken under any other law for the time being in force, the said Unit shall be liable for penal action under the provisions of the Foreign Trade (Development and Regulation) Act, 1992."

The Annual Performance Report of Dahej SEZ Units duly audited and certified by the Chartered Accountant appointed by the units are placed before the Approval Committee for monitoring in terms of provisions of Rule 22 of the Special Economic Zones Rules, 2006.
