M/s Raftaar Terminals Private Limited, Mangalore was issued Letter of Approval dated 10.10.2018 for Storage/ warehousing services.

The unit requested vide their letter dated 22.07.2019 to surrender letter of approval and exit as Dahej SEZ Unit. The case was put up in 92<sup>nd</sup> UAC Meeting held on 27.08.2019 but the applicant vide email dated 27.08.2019 has sought leave of absence hence the case was deferred for the next meeting.

In view of the above, request of M/s. Raftaar Terminals Private Limited for exit from Dahej SEZ unit is once again placed before the UAC for consideration

M/s Powerband Industries Private Limited was issued Letter of Approval on 22.04.2016, as amended from time to time, for manufacture and export of "Plastic Film ITC(HS) Code 39202020, Bopp Hotmelt Tape ITC(HS) Code 39191000, Paper Masking Tape ITC(HS) Code 48 and started commercial production from 16.04.2019.

In view of above, request of M/s. Powerband Industries Private Limited., for broad-banding of LoA of above products is placed before the committee for consideration.

Application for Broad Banding / Inclusion of additional item of export for manufacturing in the existing LoA.

M/s Fermenta Biotech Limited was issued LOA on 11.03.2010, as amended from time to time, for manufacture and export of "Vitamin D3 & its allied products" and started commercial production from 24.06.2011. Their cumulative export upto 2018-19 is Rs. 20986.95 lakhs in manufacturing activities.

Now, M/s. Fermenta Biotech Limited., Dahej-SEZ, vide their letter dated 06.09.2019 & 19.09.2019 requested for broad-banding/ inclusion of additional item i.e. Cholesterol AF 91% of ITC (HS) Code 29061310, 60 MTPA for export of manufacturing in the existing Letter of Approval. Cholesterol AF 91% is used for making feed grade material for feeding the aqua feed. Cholesterol is having different grades like Cholesterol NF, Cholesterol AF 91%, etc. They also submitted the projection for next five years period as below:-

Monitoring of Performance of Dahej SEZ units

Monitoring of Performance of SEZ unit in Dahej - SEZ in respect of performance upto the monitoring Year 2017-18.

Purpose and Statute: - Section-L of the SEZ Act, 2005, read with Rule-54 of the SEZ Rules, 2006. "Rule-S4: Monitoring of Performance:- (1) Performance of the Unit shall be monitored by the Approval Committee as per the guidelines given in Annexure appended to these rules (2) In case the Approval Committee comes to the conclusion that a Unit has not achieved positive Net Foreign Exchange Earning or failed to abide by any of the terms and conditions of "the Letter of Approval of Bond-cum-Legal Undertaking without prejudice to the action that may be taken under any other law for the time being in force, the said Unit shall be liable for penal action under the provisions of the Foreign Trade (Development and Regulation) Act, 1992."

The Annual Performance Report of Dahej SEZ Units duly audited and certified by the Chartered Accountant appointed by the units are placed before the Approval Committee for monitoring in terms of provisions of Rule 22 of the Special Economic Zones Rules, 2006.
