**66.1 Fresh Cases for Dahej-SEZ:-**

**66.1.1 M/s. Britannia Industries Ltd.**

Shri Piyush Bhandari, Head (Commercial) & Shri Arvind Guglani, Head (Project Commercial) of the applicant company appeared before the Committee, and gave a complete presentation on their project in Dahej-SEZ, as under:-

- (i) The proposal for manufacture and export of “Sweet Biscuit, Rusks, Toasted and similar toasted products {ITC (HS) – 190523100 & 19054000}”.
- (ii) Total cost of the project is Rs. 140.00 Crs., by Internal Accruals of the company; and generation of employment for 700 person;
- (iii) Total export is projected at Rs. 48841.00 lakh, with outgo of Rs. 12960.00 lakh, resulting in NFE earnings of Rs.35881.00 lakh in five years period.

The Committee after due deliberation approved the proposed project, subject to compliance of the SEZ Act, 2005 and SEZ Rules, 2006.

**66.3.1 M/s Pidilite Industries Limited Request for Broad-banding of Letter Approval –inclusion of additional products/new products to LOA.**

They intend to include of Synthetic Adhesives 1) HS Code 35061000: Products suitable for use as glues or adhesives, put up for retail sale as glues or adhesives, not exceeding a net weight of 1 kg. 2) HS Code 35069999: Prepared glues and other prepared adhesives not elsewhere specified or included, total installed capacity for Synthetic Adhesive under the HS Code 3506 1000 & 3506 9999 will be together 12,000 Tonnes per annum.

**66.3.05      M/s Prakash Chemicals International Pvt Ltd.,- Request for Trading Activity.**

Shri Anif & Shri Ankur Patel, of the applicant company appeared before the Committee and explained their request for trading activities. M/s Prakash Chemicals International Pvt. Ltd. have been issued LOA on 23/05/2013 for manufacturing. On 03/02/2014 trading activity was also included in their LOA for trading in certain items. Now the unit requested for Broad-banding of LOA for trading activities and have requested for inclusion of additional items falling under chapters 11,13,15,17,25,27,30,32,33,34,35,& 39 under the ITC (HS) Classification.

The Committee after due deliberation approved the additional items for trading in addition to existing items listed in their LOA. The approval is subject to compliance of the SEZ Act, 2005 and SEZ Rules, 2006. Further, the unit shall achieve positive NFE separately for manufacturing and trading activity and shall submit separate APRs for both the activities. No DTA sales shall be allowed for the above approved trading item.

**66.3.06      M/s Dahej SEZ Limited –Request for allotment of Plot No. Z/103/C to another unit whose application received by DSL , which is allotted to Choksi Colours Pvt Ltd.**


Shri S N Patil, CEO, Dahej SEZ Ltd, appeared before the Committee and requested for permission to allot plot No. Z/103/C, which is allotted to M/s. Choksi Colours Pvt. Ltd., to any other unit whose application is received by M/s DSL.

The Committee after due deliberation decided that since the case of M/s. Choksi Colours Pvt. Ltd. is sub-judicial before Hon'ble High Court, Gujarat, such permission cannot be granted to M/s DSL. The request of DSL shall be considered after the court case is decided.

**66.3.07      M/s Dahej SEZ Limited –Request for allotment of Office Premise on Rent basis to PCPIR RDA.**

Shri S N Patil, CEO, Dahej SEZ Ltd., appeared before the Committee and explained their request for allotment of Office Premises on rent basis to M/s. Gujarat Petroleum ,Chemicals and Petrochemicals Special Investment Regional Development Authority (GPCPSIRDA), which is under the Chairmanship of VC & MD , GIDC , Government of Gujarat. The construction of office of M/s. GPCPSIRDA is under process at GIDC, Bharuch .

The committee, after due deliberation approved the request for allotment of office premise on rent to M/s. GPCPSIRDA for temporary basis for a maximum period of 6 months or till the completion of construction of office premises of M/s. GPCPSIRDA, whichever is earlier, subject to compliance of the SEZ Act, 2005 and SEZ Rules, 2006. M/s. GPCPSIRDA will not be entitled for any SEZ benefits.
