Fresh application for setting-up new unit for manufacture and Export of Specialty Plastic Film

None of the Director or representative of the applicant company appeared before the Committee, therefore, Unit Approval Committee decided to defer the case.

Item No. 70.02.01 M/s Torrent Pharmaceuticals Limited. Dahej-SEZ
Request for HDFC Bank ATM facility in Company premises

Shri Ketan Joshi, General Manager (Finance) from M/s Torrent Pharmaceuticals Limited (M/s TPL) appeared before the Committee and explained their request in detail with presentation. He explained that M/s TPL will not charge any rent/lease from HDFC Bank. ATM will be used for withdrawal facility excluding all other activities such as issuance of DD, accepting fix deposits, Savings and Current Accounts Operations etc.

The Approval Committee after detailed discussion and considering the staff strength of M/s TPL decided to approve the proposal for installation of ATM machine of HDFC Bank in the premises of M/s TPL. M/s TPL will not claim any tax or duty benefits. The approval is also subject to compliance of SEZ Act and Rules by all concerned.

Item No. 70.03.01 M/s Britannia Industries Limited.
Surrender of Letter of Approval

M/s. Britannia Industries Limited were approved as a unit in Dahej SEZ vide LOA dated 11/03/2016. They have now requested vide their letter dated 08/09/2016 to Surrender LOA No. DAHEJ-SEZ/II/006/2015-16/1316 dated 11/03/2016. The unit has cited reasons of environmental issues and presence of other chemical units in Dahej SEZ which may be harmful to the food products to be made by the unit.

CEO, Dahej SEZ Ltd., informed that Offer-cum-Allotment letter for plot No.Z/103/B issued to M/s Britannia Industries Limited have been cancelled.

The unit has not availed any SEZ benefits. The Approval Committee after discussion approved the request of the unit to surrender Letter of Approval.
