Item No. 71.3.01M/s. Bitumode International Private Limited., Dahej – SEZ.Application for addition of Trading Activity in existing LoA

M/s Bitumode International Private Limited were issued Letter of Approval dated 02/04/2012 for manufacture of 1. Waterproofing membranes 2. Bitumode Liquids 3. Waterproofing paints 4. Road Paving materials 5. Geotextiles 6. Thermal Insulation 7. Processed Plastics.

The unit started commercial activity/production from 29.03.2016 (LOA is valid upto 28.03.2021) but they have not exported so far.

Shri Iftekhar Hussain, Resident Engineer of the applicant company appeared before the Committee and explained their request to add additional items in LOA for Trading viz. 1) Prefabricated Vertical Drains (PVD) CTH 59119090 Expected Qty. 2,50,000 Kgs. 2) Corrugated Polypropylene Boards CTH 39202090 Expected Qty. 2,60,000 kgs. 3) Atactic (Amorphous) Polypropylene (APP) CTH 39023000 7,50,000 Kgs. The cost of the project is Rs.25,00,000/- in the form of material handling equipment and will be met by internal resources

The Committee after detailed discussion approved the trading activities as per following terms and conditions and subject to compliance of SEZ Act, 2005 and SEZ Rules, 2006.

- a. The unit should maintain separate account for manufacturing products and trading activities and submit separate Annual Performance Reports.
- b. The unit should export 100% and no DTA sale will be allowed.
- c. The unit should achieve positive Net Foreign Exchange Earnings in Trading Activities.

<u>M/s Indofil Industries Limited –</u> <u>Request for amendment oif HSN code in LoA Item No.4.</u>

M/s Indofil Industries Limited., was issued LOA on 14/03/2012, as amended from time to time, for manufacture and export of Fungicide/Insecticide/Herbicide Technical 2932 MTPA.

The unit requests vide their letter no. Logistics/2016-17 dated 27.10.2016 to amend the HSN Code i.e. Cymoxanil Fungicide (ITC (HS)- 29269000) - 338 MT instead of Cymoxanil-Fungicide (ITC (HS)- Code- 38089290) - 338 MT.

None of the Promotor/Director or any Authorised Representative of the applicant unit appeared before the Approval Committee to explain their case.

As the request is not very clear, the case was deferred for proper clarification from the unit.

Item No. 71.3.3. M/s Sajjan Specialty Limited, Dahej SEZ Request for cancellation of LoA & Exit Order under Section 74A SEZ Act.

M/s. Sajjan Specialty Limited., were approved vide LoA dated 09.11.2010 for setting up of new unit in Dahej-SEZ. They have now requested vide their letter dated 04.11.2016 for cancellation of LoA of their plot in Dahej SEZ. The unit cited reasons that their foreign buyers backed out suddenly and uncertainty is prevailing in the market.

The case was discussed in the Approval Committee and Specific Officer, Dahej SEZ and Developer of Dahej SEZ were directed to furnish No Due Certificate in respect of this unit.

Item No. 71.3.04 Cancellation of Letter of Approval after lapse of validity of LOA of Dahej SEZ units

Shri Ketan Patel and Shri Dharmesh Patel of M/s Survival Technologies Pvt.Ltd. and Shri L.P. Gupta of M/s Artee Pesticides appeared before the UAC to explain their case.

SEZ - Request for extension of permission for transportation of HDPE pipes and accessories to work site at offshore segment in the Sea through SEZ road from entry gate Port area to Light House.

Shri D.C. Thakar, GM and Shri J.B. Chauhan, DGM of M/s M/s Gujarat Alkalies and Chemicals Limited (M/s GACL) appeared before the Approval Committee and explained their request for non-completion of transportation activities within the stipulated time granted in 65th UAC meeting. They assured that these activities will be completed on or before 31st January, 2017. The Approval Committee approved the extension of time up to 31st January, 2017 for the above request on the same terms and conditions approved in 65th UAC and subject to compliance of SEZ Act, 2005 and SEZ Rules, 2006.

Item No. 71.3.06 Monitoring of export performance of M/s ISGEC Heavy Engineering Limited, Dahej SEZ

Shri D.S. Bisht, Sr. Manager, Comm. and Shriram, Dy. Manager of M/s ISGEC Heavy Engineering Limited, Dahej SEZ appeared before UAC to explain their case.

The unit has completed three years but has failed to achieve Positive Net Foreign Exchange Earnings. The Committee decided to issue Show Cause Notice to the unit under FT(D&R) Act, 1992.

On scrutiny of APR for the financial year 2012-13, it is observed that FOB value of Rs. 2048.21 Lacs shown against the Capital Goods sold under EPCG (Deemed Export) not to be considered in the NFE calculation. The unit cleared the Capital Goods without payment of customs duty.

The UAC has asked to the Joint Director of DGFT to give his comments with respect to relevant provisions of FT (D&R) Act, 1992 on the above clearances within a week and the case will be put up in the next UAC.
