# 45.3.1 M/s. Rishi FIBC Solutions Pvt. Ltd.

Shri Arvind Nopany, Managing Director, of the applicant company appeared before the Approval Committee and explained the project proposal in Dahej – SEZ.

- Proposed investment is Rs. 1820.00 lakh, and employment generation for 285 person;
- > The Developer has earmarked land area 15,000 sq. mtrs for the proposed project.

- The final product will be big plastic bags which would be used for packing of foods agri products, pharmaceuticals etc. Raw material used would be mainly poly propylene for which supplier would be M/s.Reliance Industries and M/s. OPaL.

The Committee after due diligence and deliberation agreed to approve the project, subject to standard terms and conditions, of the SEZ Rules, 2006.

## 45.5 OTHER CASES :

## 45.5.1 M/S.DIC Fine Chemicals Pvt. Ltd., Dahej - SEZ:

Shri Prashant Limaye, Director-Operations, of the applicant company appeared before the Committee and explained their proposal for amendment of LOA

- a) For inclusion of additional items, viz. various type of mineral oil based inks to LOA, and
- b) For supply of goods in DTA against payment in foreign exchange, in line with the RBI Circular no. A.P. (Dir Series) Circular No. 46, dated 23-10-2012.

The Committee after deliberation and due diligence allowed/approved amendment and broadbanding of LOA to include "supply of goods and service in DTA against payment in foreign exchange, and new item i.e. mineral oil based inks.

However, the Committee observed that since DTA sale on payment of appropriate duties is allowed on achievement of NFE under the SEZ Rules, 2006. The DTA sales against payment in foreign exchange should be general and applicable for all SEZ units.

The Committee directed the DC to take-up the issue with the Ministry of Commerce & Industry, with suggestion that such activity, i.e. DTA sales against payment in foreign exchange should be counted for the purpose of calculation of NFE for the SEZ unit.

#### 45.5.2 M/s. Dahej - SEZ Ltd.,

Shri R.J. Shah, CEO of the Developer/applicant Company explained the requirement of additional items of default Authorized Operations in the SEZ, as per their request letter dated 15-03-2013. The Committee approved procurement of duty-free goods for the default Authorized Operations, viz. a) water supply line, water channels; and b) construction of building, subject to normal terms and conditions of the SEZ Rules, 2006. The Committee approved procurement of duty-free goods for the default Authorized Operations, viz. a) Water treatment plant. Water supply lines, etc; and b) electrical, distribution network, etc; and c) Roads with street lighting, signals and signage, subject to normal terms and conditions of the SEZ Rules, 2006.
