

Minutes of the 48th meeting of the Approval Committee for the multi-product Dahej – Special Economic Zone held on 16-07-2013, at 1200 hours under the Chairmanship of Shri Mahendra Jain, IAS, Development Commissioner, Dahej Special Economic Zone, in the DC Office, Dahej SEZ, Ahmedabad.

48.1 Confirmation of minutes of 47th minutes:-

As no comments/observations on the minutes of the 47th meeting of the Approval Committee for Dahej – SEZ held on 09-05-2013, were received from any member, the same were confirmed.

48.2 Report on action taken on decision of the 47th meeting of the Committee:-

Following actions were taken:-

1. M/s. Neo Corp International Ltd., - Letter of Approval (LOA) issued;
2. M/s. Prakash Chemicals International Pvt. Ltd., - Letter of Approval (LOA) issued.
3. M/s. Artee Pesticides; - query letter issued;
4. M/s. Hindustan Polyamides & Fibers Ltd., - Rejection letter issued
5. M/s. Torrent Energy Ltd., Co-Developer – letter issued for approval of goods.
6. M/s. Saphthagiri Hospitality Pvt. Ltd., Co-Developer – letter issued for approval of goods.

Consideration of applications under SEZ Rules, 2006.

48.3 FRESH CASES :

48.3.1 M/s. Barkat Metal Recycling India Pvt. Ltd., Surat:-

The applicant was not turned up for presentation of their proposed project. However, the Committee deliberated upon the application and it was observed that the proposal was setting-up a new unit in Dahej-SEZ for recycling of used imported scrap into Ferrous and Non-Ferrous metals, which cannot be considered in terms of Rule-18 (4) (d) of the SEZ Rules, 2006 quote “**(4) No proposal shall be considered for:- (d) import of other used goods for recycling.**” Unquote. Thus, the Committee decided to reject the said proposal.

48.3.2 M/s. Foam Supplies India Pvt. Ltd., New Delhi:-

The applicant vide their letter dated 16-04-2013, had sought leave of absence, and has sought time. The Committee noted the same, and decided to defer the case for next meeting.

48.4 DEFERRED CASES:

48.4.1 M/s. Artee Pesticides, Gandhinagar:-

Shri L.P. Gupta, Partner of the applicant company appeared before the Approval Committee for interview and put forth the following points:-

- i) The proposal is for formulation and packing of Pesticides, viz. Insecticides, Fungicides, Herbicides, PGR, etc.
- ii) Earlier, their proposal was deferred due to firm financial arrangement were not lined up. Now, they have tied up with financier (who is related to one of the partners) for funding the project.
- iii) Total cost of the project is Rs. 250.00 lakh.
- iv) NFE earnings would be Rs. 510.00 lakh in five years period.
- v) They have the required export markets, with high value addition.

Thus, the Committee after due deliberation approved the proposed project, subject to the standard terms and conditions of the SEZ Rules.

48.5 OTHER CASES – Broad-banding of LOA, change on name:

48.5.1 M/s. CS Performance Chemicals Pvt. Ltd., Dahej - SEZ:

Shri S. B. Desai, and Shri Uday Mehta, of the applicant company appeared before the Committee, on enquiring why approval was not taken in the beginning it was replied that it was due to oversight and explained their requirement of additional item viz. "PE Catalysts". Since, they are exporting unit in Dahej-SEZ, the proposal for broad-banding to include an additional item is in the same line of manufacturing, and the Committee approved the same, subject to standard terms and conditions of the SEZ Rules.

48.5.2 M/s. Sabero Organics Gujarat Ltd., Dahej - SEZ:

Shri Surendra Mishra, AVP of the applicant company appeared before the Committee, and explained their requirement of additional items (33 numbers as per list enclosed). On enquiring why the approval was not taken in the beginning, it was replied that it was due to oversight. Since, they are exporting unit in Dahej-SEZ, the proposal for broad-banding to include an additional item is in the same line of manufacturing, and the Committee approved the same, subject to standard terms and conditions of the SEZ Rules.

48.5.3 M/s. Nabros Top Mate Trade Pvt. Ltd., Dahej - SEZ:


Shri Keyur Patel, Director, of the applicant company appeared before the Committee, and explained their proposal for change of name to **M/s. Macson Color Chem Pvt. Ltd.**, it was informed that other overseas customers are more familiar with new name. Committee approved the same, subject to standard terms and conditions of the SEZ Rules, and execution of fresh Bond-cum-LUT in new name.

48.5.4 M/s. Torrent Energy Ltd.,

Shri Nilesh Khatri, General Manager, of the Co-Developer/applicant Company explained the requirement of additional items of default Authorized Operations in the SEZ, as per their request letters dated 44-05-2013, and 20-06-2013. The Committee approved procurement of duty-free goods for the default Authorized Operations, subject to standard terms and conditions of the SEZ Rules, 2006. Further, the Committee also decided to include one additional service of Tour Operator to the SEZ use only.

48.5.5 M/s. Sapthagiri Hospitality Pvt. Ltd.,

Shri Sumit Soni, Manager - Finance, of the Co-Developer/applicant Company explained the requirement of items of default Authorized Operations in the SEZ, as per their request letter dated 05-07-2013. The Committee approved procurement of duty-free goods for the default Authorized Operations, subject to standard terms and conditions of the SEZ Rules, 2006.
