

Minutes of the 54th meeting of the Approval Committee for the multi-product Dahej – Special Economic Zone held on 03-07-2014, at 1130 hours under the Chairmanship of Shri K. L. Sharma, ITS, Development Commissioner, Dahej Special Economic Zone, in the DC's Office, Dahej SEZ, Bharuch.

54.1 Fresh Cases for Dahej-SEZ:-

54.1.1 M/s. Thermax Limited, Pune:

Shri S. Krishnan, Global Vice President, & others of the applicant company appeared before the Committee, and gave a complete presentation on their proposed project in Dahej-SEZ, as under:-

- i) The proposal is for manufacture and export of A) Ion Exchange Resins; B) Oil Field Chemicals; and by-products like 1) polymer dry beads; 2) Spent Acid; 3) 30% HCl; and 4) Acidic Methanol;
- ii) Total cost of the project is Rs. 6400.00 lakh, is to be met from internal accruals;
- iii) Total export is projected at Rs. 156205.00 lakh, with outgo of Rs. 92253.00 lakh, resulting in NFE earnings of Rs. 63952.00 lakh in five years period.

The Committee after due deliberation approved the proposed project, subject to the standard terms and conditions of the SEZ Rules, 2006, and the proposed items of export does not fall under SCOMET.

54.1.2 M/s. Milan Laboratories India Pvt. Ltd., Thane:

Shri U. M. Deshpande, Director of the applicant company appeared before the Committee, and gave a complete presentation on their proposed project in Dahej-SEZ, as under:-

- i) The proposal is for manufacture and export of Pharmaceutical 1) Tablets, and 2) Syrup.
- ii) Total cost of the project is Rs. 4600.00 lakh, is to be met from internal accruals, and ECB;
- iii) Total export is projected at Rs. 17350.00 lakh, with outgo of Rs. 14445.00 lakh, resulting in NFE earnings of Rs. 2905.00 lakh in five years period.

The Committee after due deliberation approved the proposed project, subject to the standard terms and conditions of the SEZ Rules, 2006.

54.1.3 M/s. Silvershine Corporation, Mumbai:

Shri Shishir S. Jalundhwala, Proprietor of the applicant company appeared before the Committee, and explained their proposed project in Dahej-SEZ, as under:-

- i) The proposal is for manufacture and export of 1) Aluminum Granules; and 2) Paper Disposable Products (48185090).
- ii) Total cost of the project is Rs. 610.00 lakh, is to be met from promoters contribution and term loans;
- iii) Total export is projected at Rs. 20000.00 lakh, with outgo of Rs. 3500.00 lakh, resulting in NFE earnings of Rs. 16500.00 lakh in five years period.

The Committee during the course of deliberation informed the applicant that the first item "Aluminum Granules" cannot be considered, as the proposal involves import of

aluminum scrap for recycling into granules, and in terms of Rule-18 (4) (d) of the SEZ Rules, 2006 the proposal cannot be considered.

The Committee after due deliberation approved the second item "paper disposable products" subject to the standard terms and conditions of the SEZ Rules, 2006, and providing the specific details of the item to be manufactured and exported.

54.2 Deferred Cases for Dahej-SEZ:-

54.2.1 M/s. Breez e Intermediates Pvt. Ltd., Dahej - SEZ:

Shri Jayesh Trivedi, Director of the applicant company appeared before the Committee, and explained their request for broad-banding of LOA to include additional items to the LOA. The Committee during deliberation noted that the applicant had not specified the proper classification of the 72 items sought for inclusion to the LOA. The Committee asked to the applicant to submit the same to the Development Commissioner, Dahej-SEZ. Till the time the applicant submits the specific list of goods with proper ITC (HS) classification numbers, the case is deferred.

54.2.2 M/s. Hanzi Healthcare Pvt. Ltd., Dahej - SEZ:

Shri Puneet Mittal, Director of the applicant company appeared before the Committee, and explained their request for broad-banding of LOA to include additional items to the LOA for trading. The Committee during deliberation noted that the applicant has not specified the proper classification numbers of the list sought for inclusion to the LOA. The Committee asked to the applicant to submit the same to the Development Commissioner, Dahej-SEZ. Till the time the applicant submits the specific list of goods with proper ITC (HS) classification numbers, the case is deferred.


54.3 Other Cases for Dahej-SEZ:-

54.3.1 M/s. Accent Microcell Pvt. Ltd., Dahej - SEZ:

Shri Ghanshyam Patel, Director of the applicant company appeared before the Committee, and explained their request for broad-banding of LOA to include additional items to the LOA. The Committee after deliberation approved inclusion of two new items, viz. 1) Magnesium Stearate (MS – 28332990); and 2) Cross Carmellose Sodium (CCS – 391231000), to the LOA as broad-banding, subject to the standard terms and conditions of the SEZ Rules, 2006.

54.3.2 M/s. Tega Industries (SEZ) Ltd., Dahej - SEZ:

Shri B. K. Roy, President, of the applicant company appeared before the Committee, and explained their request for broad-banding of LOA to include additional items to the LOA. The Committee after deliberation approved inclusion of five new items, viz. 1) Vulcanized Rubber Sheet (40081190); 2) Rubber Screen Panel & Accessories (40169000); 3) Ceramic Rubber Liner (40169000); 4) Rubber line trammel structure with screen panel

(40169000); and 5) Rubber Compound (40051000), to the LOA as broad-banding, subject to the standard terms and conditions of the SEZ Rules, 2006.

54.3.3 M/s. Sapthagiri Hospitality Pvt. Ltd., Dahej - SEZ:


Shri Viren Bhavsar, Manager - Accounts, of the Co-Developer/applicant company appeared before the Committee, and explained the requirement of additional items for default Authorized Operations in the SEZ, as per their request letter dated 24-06-2014. The Committee approved procurement of duty-free goods for the default Authorized Operations, subject to standard terms and conditions of the SEZ Rules, 2006.

54.3.4 M/s. Torrent Energy Ltd., Dahej – SEZ:

Shri Ankat Rao, AGM – F&A, of the Co-Developer/applicant company appeared before the Committee, and explained the requirement of additional items for default Authorized Operations in the SEZ, as per their request letters dated 28-04-2014 and 23-05-2014. The Committee approved procurement of duty-free goods for the default Authorized Operations, subject to standard terms and conditions of the SEZ Rules, 2006. Except for the items mentioned at Sr. Nos. 33 to 106 in the list-B of their letter dated 23-05-2014, for which Co-developer may furnish justification as to how the said goods form the part of authorized operations.

54.3.5 Approval of list of services in respect of Developer and units in Dahej-SEZ:

The various SEZ co-developers, units in Dahej-SEZ, had requested for inclusion of additional 34 services to the uniform default list of services. The Committee was of the opinion that the consideration of additional services is to be examined on a case-to-case and industry specific on merit and not in general. Thus, the Committee has decided to defer the case for the next meeting for proper examination of the matter. In the meantime, the applicant may be asked to submit detailed justification of each additional services required for their authorized operations.
