

Minutes of 100<sup>th</sup> meeting of the Approval Committee for Dahej Special Economic Zone held on Wednesday, 24<sup>th</sup> March, 2021 at 12.00 hours through Video Conferencing.

Item No. 100.03.01                      M/s Fermenta Biotech Limited,-  
Application for Broad Banding / Inclusion of additional items of export and enhancement capacity for manufacturing in the existing LoA.

Shri Uddhav Deshmukh, VP & Shri Hitesh Patel, AGM from M/s Fermenta Biotech Limited appeared before the Committee through WEBEX video conference and explained their request.

M/s. Fermenta Biotech Limited, Dahej-SEZ, vide their letter dated 13.03.2021 requested for broad-banding/ inclusion of additional items i.e. Sensitiser of ITC (HS) Code 2905, 5 MTPA and VITAMIN K1 of ITC (HS) Code 29362990, 6 MTPA for export of manufacturing in the existing Letter of Approval and enhancement of capacity of the existing products of their LoA.

The Committee after the detailed discussion approved the request for Broad Banding / Inclusion of additional items of export, except item at sr. no.11 i.e. PHENYRAMIDOL HCL and enhancement capacity for manufacturing in the existing LoA subject to clearance/NoC from GPCB. The approval is subject to compliance of SEZ Act, 2005 and Rules, 2006 and all other relevant Rules and Regulations. All other terms and conditions mentioned in the Letter of Approval shall remain unaltered.



**Item No. 100.03.02**     **M/s Godrej & Boyce Mfg.Co.Ltd**  
**Application for Broad Banding permission in the  
existing LoA.**

Shri Vivek Soans, Plant Head from M/s Godrej & Boyce Mfg. Co. Ltd., appeared before the Committee through WEBEX video conference and explained their request.

The Approval Committee noted and approved the decision taken by the Development Commissioner for broad banding permission of M/s. Godrej & Boyce Mfg. Co. Ltd subject to clearance/NoC from GPCB. The approval is subject to compliance of SEZ Act, 2005 and Rules, 2006 and all other relevant Rules and Regulations. Shri Brijesh Srivastva and Shri Mehul Vakharikar representatives from M/s Coromandel International Limited appeared before the Committee through WEBEX video conference and explained their request.

The Approval Committee after detailed discussion approved the request of M/s. Coromandel International Limited for granting permission for underground pipeline from M/s. Coromandel International Limited, Plot no. Z/103/G, Dahej SEZ-II (Drainage Point) to GIDC pumping station within Dahej SEZ land limit. The approval is subject to compliance of SEZ Act, 2005 and Rules, 2006 and all other relevant Rules and Regulations prevailing in SEZ Area and norms / instructions of concerned authorities viz., Pollution Control Board, Dahej SEZ Ltd. and GIDC.
