New Application for setting up unit in Dahej SEZ.



The approval is subject to compliance of the SEZ Act, 2005 and SEZ Rules, 2006, and also that proposed items of export do not fall under SCOMET.

Shri Deshmukh Uddhav, General Manager (manufacturing) of the applicant company appeared before the committee and explained their request for broad-banding/inclusion of additional item in the existing LOA.

The committee after detailed discussion approved the request for enhancement of capacity of the existing products of their Letter of Approval. All conditions of Letter of Approval shall remain same, further the approval is subject to compliance of SEZ Act, 2005 and SEZ Rules, 2006. S/Shri Kedar Sanghvi, Sandip Bose and Mahesh Tailor of the applicant company appeared before the Committee and explained their request for broad-banding of intermediate bulk drugs under ITC (HS) code No. 29420090 in LoA.

Shri J.P. Meena, Assistance Commissioner of Custom & Central Excise and a member of the committee raised the point for proper classification of chapter heading of the Mesalamine Crude.

A representative from the unit have informed to the committee that they will submit the clarifications/justification to the Office of DC, Dahej and after that the same clarifications/justification will be forwarded to Shri J.P. Meena for their comments.

The committee decided that the request of the unit will be considered for approval after receipt of reply from Shri J.P. Meena.

Ltd have submitted their APRs for the financial years 2014-15 & 2015-16 on 28.03.2017 & 14.03.2017 respectively.



In view of the above, the committee decided to drop the show cause notices issued to these units for non-submission of Annual Performance Reports.
