M/s Mahadi Organics Private Limited,Application for Setting up Unit in Dahej
SEZ

Shri Ajit Shah, Director of applicant company appeared before the committee and explained their proposal in detail for setting up unit in Dahej SEZ.

- (i) The proposal is for manufacture and export of Tetraphenyl Ethylene Triphenylmethane 1,3,5- Tri-tert butyl benezene 1,1'- (1-Methylethylidene) BIS (4-(Octyloxy) Benezene Trans 1,2 Diaminocylohexane FG900337-020
- (ii) Total cost of project is Rs.1200.00 lakhs and the project will generate employment for 50 persons.
- (iii) Total export for five years is projected at Rs.15200.00 lakhs with outgo of Rs. 2033.28 lakhs, resulting in Net Foreign Exchange earnings of Rs. 13166.72 lakhs in five years.

The committee discussed the proposal in detail. The committee decided to approve the proposal subject to compliance of SEZ Act, 2005 and SEZ Rules, 2006.

## M/s Raftaar Terminals Private Limited,-Application for Setting up Unit in Dahej SEZ

Shri Manmohan Prabhu, Manager (operation) and Shri Y.N. Narayn, Engineer of applicant company appeared before the committee and explained their proposal in detail for setting up unit in Dahej SEZ.

The proposal to incorporate the liquid storage terminal for chemicals, petroleum and Non Classified/Edible oil products. Cargo shall be loaded using pumps in to Rail wagons & Truck Tankers. Rail wagons shall move inside the terminal through proposed rail siding for the terminal and tanker trucks shall come in through build-in roads inside Dahej SEZ. Ships will be loaded using export pumps by means of loading arms proposed to be installed at proposed Jetty for the Terminal facility. Tanks and jetty pipeline for specialized Acids & products.

- (i) The proposal is for storage/warehousing activity
- (ii) Total cost of project is Rs.17500.00 lakhs and the project will generate employment for 100 persons.
- (iii) Total export for five years is projected at Rs.3851833.00 lakhs with outgo of Rs. 3775218.00 lakhs, resulting in Net Foreign Exchange earnings of Rs. 76615.00 lakhs in five years.

The committee discussed the proposal in detail. The applicant company propose to establish a new tank terminal for storing class A,B, C in Coastal Regional Zone of Dahej SEZ. Since the matter pertains to the Coastal Regional Zone area, therefore representative of Gujarat Meritime Board(GMB) was also called to assist and advise in this matter in the UAC. Since none of the representative was present from GMB and the unit have been asked to submit export, import and NFE data for service component only, therefore, the committee decided to defer the case.

## Item No. 82.03.01 M/s Shiva Pharmachem Limited. Broad banding of manufacturing items

Shri Viral Trivedi, VP (operations) and Shri Amit Trivedi, Sr.GM (commercial) appeared before the committee and explained their request in detail.

M/s Shiva Pharmachem Limited submitted letter No.SPL/Dahej-SEZ/LOA/Addition dated 05-07-2018 enclosing the list of additional manufacturing items as per enclosed Annexure under chapter 29 of ITC (HS) code and requested to add in the Letter of Approval without enhancing existing LOA capacity. The above request was deferred in 81st UAC for want of details of investment, employment generation, import of capital goods and raw material, projected net foreign exchange earnings for five years of additional manufacturing items. The applicant unit vide their letter dated 14.08.2018 submitted the projected investment, NFE and manpower.

The Approval Committee after detailed discussion unanimously approved request to add the enclosed list of items as per Annexure without enhancing

Request for One Time Permission to manufacture and export new products.

Shri Viral Trivedi, VP (operations) and Shri Amit Trivedi, Sr.GM (commercial) appeared before the committee and explained their request in detail.

M/s. Shiva Pharmachem Limited., vide their letter dated 01.08.2018 and e-mail dated 01.08.2018 requested for One Time Permission for manufacture and export of 1) Parachloro Metaxylenol (3,5-dimethyl-4- chloro phenol) (PCMX), 2) Pentenoyl Chloride, 3) Propan-2-yl-5-chloro-4-4methyl-2-2nitrobenzonate (CMNBP) which were in list in Annexure for broad banding deferred 81st UAC Dahej SEZ held on 24.07.2018.

The applicant unit mentioned that there is an urgent need to fulfill their supply commitments of above three products requested for one time permission immediately to the globally reputed clients for all their future business with them which they consider to be a great opportunity. Considering the genuiness of the request for one time permission for manufacture and export of these three items, Development Commissioner, Dahej SEZ has approved their request subject to the request shall be placed in the next UAC for ex-facto approval.
