**Proposal for Setting up of New Units in Dahej SEZ.**

Shri Manmohan Prabhu, Manager (operation) and Shri Y.N. Narayn, Engineer of Applicant Company appeared before the committee and explained their proposal in detail for setting up unit in Dahej SEZ.

The proposal to incorporate the liquid storage terminal for chemicals, petroleum and Non Classified/Edible oil products.

- (i) The proposal is for storage/warehousing activity
- (ii) Total cost of project is Rs.17500.00 lakhs and the project will generate employment for 100 persons.
- (iii) Projected FOB Value of Export in first 5 years Rs. 25803.00 Lakhs, Foreign Exchange Outgo in first 5 years NIL & Net Foreign Exchange Earnings for the first five years Rs. 25803.00 Lakhs.

**Request for Removal of waste generated during the production process.**
