Minutes of 99<sup>th</sup> Meeting of the Approval Committee for Dahej Special Economic Zone held on Wednesday, 23<sup>rd</sup> December, 2020 at 12.30 hours through Video Conferencing.

A. List of participants is annexed as per Annexure-A. (The quorum is complete as per section 13(5) of the SEZ Act, 2005 read with Notification dated 26.07.2007 of MOCI issued from F. No. 1/1/2006-SEZ, as out of the present, there were four designated members).

B. Ratification of the Minutes of last meeting of the Approval Committee.

As no comments/observations on the minutes of 98<sup>th</sup> meeting of the Approval Committee of the Dahej SEZ held on 05.11.2020 have been received from any member, Minutes of the Meeting as circulated earlier were unanimously ratified.

Item No. 99.03.01 M/s ONGC Petro additions Limited., Dahej SEZ

Request for approval for allotment of 2,20,000 Sq.Mtrs

(Approx) land in Dahej SEZ.

Shri Avinash Verma, MD & Shri Rajendra Parakh, GM from M/s ONGC Petro additions Limited appeared before the Committee through WEBEX video conference and explained their request for inclusion of additional land of 2,20,000 Sq.mts (approx). They have also got letter dated 22.07.2020 from Dahej SEZ Limited for allotment of 2,20,000 Sq.Mtrs. approximate land in the processing area of Dahej SEZ. M/s. OPAL have requested for allotment of additional land to DSL for the construction of road post exit of OPAL from Dahej SEZ. They are starting the process and creating the infrastructure for the final exit. During the process, they require to create separate entry & exit route, road and other necessary infrastructure.

During the meeting the Committee deliberated the report of Specified Officer, Dahej SEZ submitted vide letter dated 21.12.2020 and observed that there are pipelines viz. DSL/ GIDC Water Supply Network, M/s. TPL (DGEN) dedicated water supply pipeline, M/s. Reliance Ind. Ltd. dedicated water supply pipeline, M/s. Opal water supply & Napththa pipeline, etc. (as informed by DSL) are passing through the said land. Further, if OPAL makes any kind of construction on this land later on, the disposal of storm water would be obstructed and lead to heavy water logging inside the SEZ. At present, many SEZ units are located in proximity of existing storm water network and it may not be possible for other units /co-developers to use the same network freely once the land is allotted to M/s. OPAL. Since the pipelines are passing through the corridor, may the right of use should not be affected to the existing units along with the right of Office of the Developer and Office of Development Commissioner.



Shri Atul Sharma, Manager, Gujarat Maritime Board has offered his comments vide email dated 23.12.2020 that if the allotment of land to M/s OPAL structures fall in GMB port limits and neighboring waterfront, NOC of GMB along with CRZ Clearance would be required to be obtained prior to commencement of the activities. So, let them know the pin point locations with geo-coordinates in grid maps for both the projects.

The Committee after due deliberation approved the request for additional of allotment of land of 2,20,000 sq. mtrs. approximate land, subject to NOC/ Clearance from GMB and compliance of SEZ Act, 2005 and SEZ Rules, 2006 and all relevant Rules & Regulations. The Committee directed the Developer, Dahej SEZ to ensure that common utilities passing through the additional land to be allotted to OPAL should not affect in future and Developer / Co-developer / Concerned Agency which are looking after the common utilities are allowed to enter the land hassle-free for uninterrupted supply of their services. Developer, DSL shall obtain the Undertaking / Bond from OPAL to that effect to avoid any litigation in future before issuing final letter of allotment of additional land to OPAL.
