**FRESH CASES :**

**1. M/S. STERLING AUXILIARIES PVT. LTD.**

Shri Ajit Parekh , Director of M/S. STERLING AUXILIARIES PVT. LTD. appeared before the Approval Committee for personal Interview & explained about the proposed project in Dahej SEZ. He informed that they intend to manufacture Specialty Chemicals falling under Ch-29,30,34,38,39 (surfactant active agents) of ITC {HS} in their proposed SEZ Unit & the said product will be exported to various countries of South East Asia, Middle East Asia, UK, Japan & Australia. The Applicant intend to import and procure capital goods worth Rs. 1500.00 Lakhs for the proposed project. FOB value of exports for the 5 years period is projected as Rs. 49500.00 Lakhs with NFE of Rs. 16700.00 Lakhs (50.91%). The Developer (Dahej SEZ) has agreed in principle approval for allotment of plot of about 50,000 Sq. Mtrs. in the processing zone of Dahej SEZ for the proposed project in Dahej SEZ for setting up of unit.

Shri Ajit Parekh has further informed that they are having unit in DAHEJ area of District Bharuch, which is engaged in the manufacture and export of similar products & their export turnover was Rs.84 Crores during last year. The proposal was approved by the Approval Committee subject to standard terms & conditions.

**2. M/S. PARSHWNATH PIGMENTS LTD.**

Shri Rajesh Jobalia, Director of M/S PARSHWNATH PIGMENTS LTD appeared before the Approval Committee for personal Interview & explained about the proposed project in Dahej SEZ. He informed that they intend to manufacture and export of 1) CPC Blue & its derivatives, 2) Alpha Blue, 3) Beta Blue, 4) Cobalt Phthalocynaine, 5) Solvent Dyes falling under Ch-32 of ITC (HS) in their proposed SEZ Unit. He further informed that one of their major customer M/s DIC FINECHEM LTD has already set-up an unit in DAHEJ SEZ. The Applicant intend to import and procure capital goods worth Rs. 1000.00 Lakhs for the proposed project. FOB value of exports for the 5 years period is projected as Rs. 45300.00 Lakhs with NFE of Rs. 11860.00 Lakhs (35.47%). The Developer (Dahej SEZ) has agreed in principle approval for allotment of plot of about 50,000 Sq. Mtrs. in the processing zone of Dahej SEZ for the proposed project in Dahej SEZ for setting up of unit.

Shri Rajesh Jobalia had further informed that they are already exporting their products/ pigments manufactured by their DTA unit to China, Malaysia & other countries. The export turnover of their DTA unit was Rs.25 Crores during last year. The proposal was approved by the Approval Committee subject to standard terms & conditions.

**3. M/S. TORRENT PHARMACEUTICALS LTD.**

Shri Raghu Parakh, Vice President (Commercial) of M/S. TORRENT PHARMACEUTICAL LTD. appeared before the Approval Committee for Personal Interview & explained about the purpose of seeking the approval of various taxable services. However on being asked by the approval committee, he could not justify their request for approval of few taxable services not covered by the default list of services already approved by the approval committee. However UAC members approved following services which are immediately required by the unit.

**4. M/S. TORRENT ENERGY LTD.**

Shri Pramod Jhavar, Asst. General Manager of M/S TORRENT ENERGY LTD appeared before the Approval Committee for Personal Interview. The unit approval committee directed Shri Pramod Jhavar that a senior official/ director of the company should appear before the approval committee & decided not to take cognizance of the presence of Shri Pramod Jhavar. Further, the approval committee decided that the applicant should be asked to re-submit their request for approval of taxable services along with brief justification regarding consumption of the same by their SEZ unit.

**5. M/S. DAHEJ SEZ LTD.**

Shri R J Shah, Chief Executive Officer of M/S DAHEJ SEZ LTD (Developer) put up a request before the approval committee for the approval of the import of two sets of "Prefabricated Building and Building Structures and parts thereof" totally valued at Rs.44 Lakhs, vide their letter no. DSL/SEZ/09-10 dated 20/10/2009. Shri R J Shah informed the approval committee that the said material is required for construction of "Customs Office" in DAHEJ SEZ immediately. The members of approval committee perused the document/ letter put up before them by Shri R J Shah and decided to give their approval to the request of the Developer.
