#### FRESH CASES: -

### 1. M/S. FERMENTA BIOTECH LTD.

Shri Keshav H. Kashid, Chief Finance Officer of M/s.DIL Limited, Shri Rajendra Gaitonde, Director-Operations of M/s.Fermenta Biotech Ltd., Shri Sudarshan G. Kamath, General Manager-Finance of M/s.Fermenta Biotech Ltd. and Shri Anil Bharati, Manager-Projects of M/s.Fermenta Biotech Ltd. were approval committee for personal interview and explained about their proposed project in Dahej SEZ. Shri Kamath has made a presentation regarding their project.

M/s.Fermenta Biotech Ltd. is a subsidiary of M/s.DIL Limited, a company listed on Bombay Stock Exchange (BSE), and have manufacturing facility at Kullu, Himachal Pradesh. At present they are planning to manufacture Vitamin D<sub>3</sub> in Phase-I. M/s.Fermenta Biotech Ltd. is the only manufacturer of Vitamin D<sub>3</sub> in India and they are manufacturing the same since last three decades. The company has recently received 'Certificate of Suitability' (CEP) from EDQM (European Directorate for Quality of Medicines). Currently there are only three such CEP recognized manufacturers of Vitamin D<sub>3</sub> including them globally.

Shri Kamath stated that their products demand is increasing consistently. Therefore, they have to expand their manufacturing capacity. It is physically and also statutorily not possible to enhance the capacities at Kullu and so they are interested to develop the project in Dahej SEZ.

Their FOB value of exports for the 5 years is projected as Rs. 14,328 lacs with NFE of Rs.7,881 lacs. The manpower requirement for phase-1 in Dahej SEZ is 101 persons. The Developer (Dahej SEZ Ltd.) has agreed in principle approval for allotment of plot of about 30,000 Sq.Mtrs. in the processing zone of Dahej SEZ for setting up of unit.

Accordingly, the proposal of M/s.Fermenta Biotech Ltd. Approval Committee subject to standard terms and conditions.

#### OTHER CASES: -

# 1. M/S.OIL AND NATURAL GAS CORPORATION LIMITED.

Shri P.V. Satyaprakash, DGM(P) and Shri S.K. Sharma, Chief Engineer of M/s. Oil and Natural Gas Corporation Limited appeared before the approval committee and requested for approval of taxable services list with a view to claim to refund service tax of the same.

The services of cable operators, dry cleaning etc. which will be used outside SEZ are denied. It was decided that the services which are in the default list of services may be approved and for remaining services the unit has to re-examine the need of them and put up to the Development Commissioner's office with proper justification to put up to the approval committee.

# 2. M/S.CS SPECIALTY CHEMICALS PVT. LIMITED.

M/s. CS Specialty Chemicals Pvt. Limited has requested to accord the LOA in the name of M/s.CS Performance Chemicals Private Limited which is wholly owned subsidiary of M/s.CS Specialty Chemicals Pvt. Ltd.

However, nobody appeared on behalf of M/s.CS Specialty Chemicals Pvt. Ltd. The matter has been deferred to the next UAC's meeting.

### 3. M/S.TORRENT ENERGY LIMITED.

Shri Kapil Khandelwal, Vice President(Finance & Operation) of M/s.Torrent Energy Limited appeared before the approval committee. M/s.Torrent Energy Limited has submitted a list of authorized operations for the approval of UAC.

As the list is very long with more than 15 pages, the committee is opined that list has to be scrutinized. As the list was submitted at the time of meeting no member could go through it properly. So the matter has been deferred to the next meeting of UAC.
