## 34.5.1 M/S.MEGHMANI CHEMTECH LTD.

Shri M.V. Mori, GM and Shri K.D. Mehta of M/s. Meghmani Chemtech Ltd. appeared before the Approval Committee for interview and put forth the following points:

- LOA No. KASEZ/DCO/03/MOL/08-09 dated 05.05.2008 was issued to M/s. Meghmani Organics Ltd. (MOL). Thereafter, the unit requested to change/transfer the name of the promoter company from MOL to M/s. Meghmani Chemtech Ltd. (MCL), as the company intended to set up their project in Dahej SEZ under a Special Vehicle Company. The matter was discussed in the Unit Approval Committee (UAC) meeting dated 19<sup>th</sup> August 2008 and the proposal was approved. Accordingly, the name of the promoter company was changed from MOL to MCL vide letter dated 08.09.2008.
- The new company i.e. M/s. Meghmnai Chemtech Ltd. (MCL) was promoted by M/s.
  Meghmani Organics Ltd. (MOL) and there was 97% Equity Share holding of MOL in
  MCL. Thus MCL is a subsidiary of parent company MOL and MOL has funded the
  entire project of MCL till date.

- The parent company i.e. MOL is a Branded Company and listed in stock exchange.
- The earlier change of enterprise from MOL to MCL was done for availing the full income-tax benefits, which were available to separate SEZ unit only.
- Present change in enterprise is required due to change in Section 10 AA of Income
  Tax Rules (effective from 1-4-2009) which now enable SEZ unit to have tax benefits
  over total turnover of the SEZ Unit, instead of Total Turnover of the business of the
  taxpayer. Therefore, it was not necessary for them now to have a separate company
  for SEZ unit for availing full tax benefits.
- MCL will be merged in the MOL after getting permission from UAC and Registrar of Companies.

#### Observations/Clarifications of the Committee:

After detailed deliberation, the proposal was approved by the Approval Committee on the following conditions:

- MCL would file their separate income-tax returns till the date of approval.
- MOL would maintain separate books of accounts for SEZ unit.

#### 34.5.2 M/S.THE SARSWATI INDUSTRIAL SYNDICATE LTD.

Shri M.L. Bajaj and Shri D.S. Bisht of M/s. Saraswati Industrial Syndicate Ltd. appeared before the Approval Committee for interview and put forth the following points:

- Shareholders of M/s Saraswati Industrial Syndicate Ltd passed the Board resolution in extra-ordinary General Meeting dated 12.08.2011 regarding change of name from "The Saraswati Industrial Syndicate Ltd." to "ISGEC Heavy Engineering Ltd."
- Accordingly, Certificate of Registrar of Companies regarding change of name alongwith Memorandum and Articles of Association in the new name of the company was submitted to DC office.
- PAN Card number of M/s. Saraswati Industrial Syndicate Ltd and M/s ISGEC Heavy Engineering Ltd were same.

#### Observations/Clarifications of the Committee:

After detailed deliberation, the proposal of the unit for change in name was approved by the UAC.

### 34.5.3 M/S.CAMBAY SEZ HOTELS PVT. LTD.

Shri Suresh Kumar and Shri Shibu Pillai of M/s. Cambay SEZ Hotels Pvt. Ltd., Co-Developer appeared before the Approval Committee for interview and put forth the following points:

 Permission for purchase of 2000 cubic metric tons of Ready Mix Concrete (RMC), valued worth ₹ 70,00,000/- was required for authorized operations.
