

Minutes of the 5<sup>th</sup> (fifth) meeting of the Approval Committee for the multi-product Dahej – Special Economic Zone held on 12-02-2009, at 1630 hours at Vadodara under the Chairmanship of Shri Ravi S Saxena, IAS, Development Commissioner, Dahej Special Economic Zone, in the conference room of OPAL, VCCI Complex, Makarpura, Vadodara.

Following cases were deliberated and taken-up for consideration:-

## A) Fresh Cases:-

# 01) Torrent Energy Ltd., Ahmedabad:-

Shri Sudhir Shah, Executive Director of the applicant company appeared before the Approval Committee for a personal interview. The Chairman on going through the proposal had intimated that the applicant company is co-developer at Dahej and have the requisite approval for the same and further informed the Committee that the applicant company (co-developer of the SEZ) shall have to approach the Govt. (BOA) for getting necessary approval/clearance for their proposed Authorized Operations in the SEZ, this was second by other member of the Committee including the Commissioner of Central Excise. Thus, the Committee advised the applicant to make required application to the Board of Approval in the Ministry of Commerce & Industry.

# 02) James Robinson India Pvt. Ltd., Vapi-

Shri Sandip Zaveri, Director of the applicant company appeared before the Committee for personal interview, and explained about the proposed project in Dahej – SEZ. The proposal is to set up a new unit for manufacture and export of Fuel Dyes. Proposed investment for the project is to the tune of Rs. 275.00 lakhs, which shall be met internal accruals and suppliers' credits.

They intend to procure capital goods worth Rs. 275.00 lakhs for the proposed project. FOB value of export is projected to be Rs. 184.36 crores for a period of 05 (five) years, with NFE of Rs. 31.50 crores. The Committee observed that there are no Domestic Tariff Area (DTA) sales from the proposed project. There are also no cases against them from the Central Excise & Income Tax side, as stated by the Directors. Thus, the proposal was approved by the Approval Committee subject to standard terms & conditions.

### Review of approval given by the Development Commissioner (DC), B-01Dahej - SEZ to Meghmani Organics Ltd., Ahmedabad:-

The case was reviewed by the Committee, and the Chairman had proposed that the approval holder to given Show Cause Notice, with reference to contravention of Central Excise Act & Rules thereof in the fake invoices case, which was reported by the Commissioner of Central Excise, Vadodara-II. Thus, the Committee came to a conclusion that the DC, Dahej - SEZ shall issue SCN to the approval holder in this regard with a point for cancellation of LOA issued to them, and thereafter the case may be put-up before the Committee for a decision.

#### Other item (table agenda):-C)

The JDC, Dahej - SEZ had put-up the Central Excise case of tax evasion against M/s. ABG Shipyard Ltd., wherein the Commissioner of Central Excise, Vadodara-II had pointed out that the said case is still under investigation and adjudication is pending and thus advised to awaited proceedings in this regard.

In the meantime Committee decided to issue SCN to approval holder in this regard with a point for cancellation of LOA issued to them and thereafter the case may be put-up before the Committee for decision.
