This product is Organo Metalic Compound and as per chemical composition, the same was classified under HS Code 29310090 in the LOP, however as per it's actual use and application, it being a Catalysts by nature, the same more appropriately is classifiable under HS Code 3815900. They also informed that during discussion with their overseas customers and also their technical team, they are also emphasizing under said HS code 38151900.

In view of the above, unit has requested to amend the HSN code in the existing LoA as follows:

During the meeting one of committee member raised the question regarding clarification of MEIS/RodTep or any rate of duty on Import & Export. Unit vide their letter dated 04.06.2024 informed this office that the rate of MEIS/RodTep or any duty on Import or Export is the same in the case of both the HSN viz. 38151900 and 29310090 and there is no difference of rate/duty.

Further, the unit also undertakes to pay, on demand by the department, any difference in rate of duty/ tax or any amount due or any incentives wrongly claimed, in future. The firm has also informed that there has been no objection/investigation by any agencies regarding the classification and the request for change of classification is only on account of the buyer's request.

In this regard, the Specified Officer, Dahej has raised the query for change in HSN classification of goods.

The Approval Committee after detailed discussion unanimously **deferred** the request for amendment of the product ITC (HS) code in existing LoA and sent the proposal to SO, Dahej for examination and send their comments about change in HSN Classification.
